Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly enroll you in an Essential Plan with enrollment start date of February 1, 2018?

Procedural History

On December 26, 2017, you submitted an application for financial assistance through NYSOH.

On December 27, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to enroll in the Essential Plan with a \$20.00 premium per month for a limited time, effective February 1, 2018. The notice instructed you to provide proof of your income by March 26, 2018 to confirm your eligibility.

Also on December 27, 2017, NYSOH issued a plan enrollment notice confirming that as of December 26, 2017, you were enrolled in an Essential Plan with an enrollment start date of February 1, 2018.

On December 29, 2017, you spoke with NYSOH's Account Review Unit and requested an appeal relative to the enrollment start date of your Essential Plan.

On March 2, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. Testimony was taken during the hearing, and the record was closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- According to your NYSOH account, you are applying for health insurance for yourself.
- On December 27, 2017, you uploaded a termination letter from your former employer, to your NYSOH account. The letter states that your health insurance benefits would end on October 31, 2017, and your former employer would provide you with information on your eligibility to continue your medical coverage under COBRA (see Document
- 3) According to your NYSOH account and testimony, on December 26, 2017, you enrolled in an Essential Plan.
- 4) You testified that you have outstanding medical expenses for the months of November 2017 and December 2017, and want your health plan to be backdated to cover those medical expenses.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan - Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see https://www.medicaid.gov/basic-health-program/basic-health-program.html).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether NYSOH properly enrolled you in an Essential Plan with enrollment start date of February 1, 2018.

The record reflects that on December 26, 2017, you submitted an application for financial assistance through NYSOH. Based on that application, you were determined eligible for the Essential Plan and selected a health plan.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

The record reflects that you selected the Essential Plan on December 26, 2017. Since the health plan was selected on December 26, 2017, the plan properly began on the first day of the second following month; that is, as of February 1, 2018.

Therefore, the December 27, 2017, enrollment notice is AFFIRMED.

Decision

The December 27, 2017 plan enrollment notice is AFFIRMED.

How this Decision Affects Your Eligibility

Your Essential Plan had a plan enrollment start date of February 1, 2018.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This

must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
