Issues

The issue presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that you were not eligible to receive advance payments of the premium tax credit, as of January 31, 2018?

Did NY State of Health properly determine that you were not eligible to receive cost-sharing reductions?

Procedural History

On November 27, 2017, NY State of Health (NYSOH) received your updated application for financial assistance with health insurance.

On November 28, 2017, NYSOH issued an eligibility redetermination notice, stating that you were eligible for advance payments of the premium tax credit (APTC), up to \$175.00 per month, for a limited time, effective January 1, 2018. That notice further stated that additional information was required to confirm your eligibility and that you needed to provide proof of income by February 15, 2018.

On December 27, 2017, you uploaded proof of income to your NYSOH account.

On December 28, 2017, the income information you submitted was verified, the income information in your account was updated, and your eligibility was re-run.

On December 29, 2017, NYSOH issued an eligibility redetermination notice, stating that you were newly eligible to purchase a qualified health plan at full cost, effective February 1, 2018. The notice further stated that you no longer qualified for APTC as of January 31, 2018, this was because the income you provided was over the allowable income limit for all financial assistance programs.

On December 30, 2017, NYSOH issued an enrollment confirmation notice, stating that you were enrolled in a full-pay qualified health plan, effective January 1, 2018.

On January 2, 2018, you spoke to NYSOH's Account Review Unit and appealed that eligibility determination notice insofar as you were not found eligible to receive financial assistance.

On March 13, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your tax return for 2018 with a tax filing status of single. You will claim no dependents on that tax return and claim no deductions.
- 2) You testified that you are specifically appealing your eligibility to receive APTC.
- 3) The application that was submitted on December 28, 2017, listed annual household income of \$58,732.00, consisting of \$58,706.00 you earn from your IRA distributions and \$26.00 in taxable interest. You testified that this amount was correct.
- 4) Your application states that you will not be taking any deductions on your 2018 tax return.
- 5) You testified that paying a higher premium for health insurance would make it more difficult to stay where you currently are as you rely on IRA distributions for income.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Advance Payments of Premium Tax Credit

APTC are generally available to a person who is eligible to enroll in a qualified health plan and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

For purposes of APTC, the household size equals the number of individuals for whom the taxpayer is allowed a deduction under 26 USC § 151 for the taxable year, which typically includes: (1) the taxpayer, (2) his or her spouse, and (3) any claimed dependents (26 USC § 36B(d)(1)).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (81 Fed. Reg. 4036.).

Cost-Sharing Reductions

Cost-sharing reductions are available to a person who (1) is eligible to enroll in a qualified health plan through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level qualified health plan (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

Modified Adjusted Gross Income

NYSOH bases its eligibility determinations on modified adjusted gross income as defined in the federal tax code (45 CFR § 155.300(a)). The term “modified adjusted gross income” means adjusted gross income increased by (1) any income that was excluded under 26 USC § 911 for United States citizens or residents living abroad, (2) tax-exempt interest received or accrued, and (3) Social Security benefits that were excluded from gross income under 26 USC § 86 (see 26 USC § 36B(d)(2)(B), 26 CFR § 1.36B-1(e)(2)).

“Adjusted gross income” means, in the case of an individual taxpayer, gross federal taxable income minus certain specific deductions, such as expenses

reimbursed by an employer, losses from sale or exchange of property, losses from premature withdrawal of funds from time savings accounts, deductions attributable to royalties, and certain retirement savings (26 USC § 62(a)). Living expenses, such as rent and utilities are not an allowable deduction in computing adjusted gross income (*id.*).

Legal Analysis

The first issue is whether NYSOH properly determined that you were not eligible to receive APTC, as of January 31, 2018.

You expect to file your 2017 income taxes as single and will claim no dependents on that tax return. Therefore, you are in a one-person household.

The application that was submitted on December 28, 2017 listed an annual household income of \$58,732.00 and the eligibility redetermination relied upon that information. NYSOH bases its eligibility determinations using modified adjusted gross income (MAGI). The record indicates that your income consists almost solely of IRA distributions that you receive. IRA distributions are included in MAGI and therefore correctly included when NYSOH determines your eligibility for financial assistance.

Since the annual 2017 FPL for a one-person household is \$12,060.00, you might qualify for APTC if your annual household income is between \$16,642.80 (138% FPL) and \$48,240.00 (400% FPL).

Your household income of \$58,732.00 places you at 486.99% of the FPL. Because your household income of \$58,732.00 is above the \$48,240.00 allowable maximum household income for this program, you are not eligible for APTC based on your attested income level alone.

The second issue is whether you were properly determined ineligible for cost-sharing reductions. Cost-sharing reductions are available to a person who has a household income no greater than 250% of the FPL and is eligible for APTC. Since you are not eligible for APTC and your household income exceeds 250% of the FPL, NYSOH correctly found you to be ineligible for cost sharing reductions.

Therefore, since the December 29, 2017 eligibility redetermination notice properly stated that you were not eligible for APTC, it is correct and is **AFFIRMED**.

Decision

The December 29, 2017 eligibility redetermination notice is AFFIRMED.

Effective Date of this Decision: March 19, 2018

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

You continue to not qualify for APTC, effective February 1, 2018.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
