On December 27, 2017, NY State of Health (NYSOH) issued an eligibility determination notice, stating that your youngest child was eligible for Child Health Plus with a \$45.00 monthly premium, effective February 1, 2018. You appealed this determination.

On February 27, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for March 19, 2018 at 11:00 AM.

On March 19, 2018, a Hearing Officer placed two calls to the telephone number that you provided to NYSOH, [REDACTED], at 11:00 AM and 11:01 AM, but that number was not in service. The Hearing Officer then placed three calls to another telephone number listed in your NYSOH account, [REDACTED], at 11:02 AM, 11:15 AM, and 11:30 AM, but was unable to reach you. If your contact information has changed, please contact NYSOH immediately and update your account.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
