On December 22, 2017, NY State of Health (NYSOH) issued an enrollment notice confirming that as of December 21, 2017, you were enrolled in an Essential Plan with an enrollment start date of February 1, 2018. You requested an appeal insofar as the enrollment start date of your Essential Plan.

On March 9, 2018, you had a scheduled telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. At the hearing, you stated that the issue under appeal was resolved and withdrew your appeal on the record through sworn testimony

Accordingly, we are dismissing your appeal.

### **How does this Dismissal Affect Your Eligibility?**

The Appeals Unit of NY State of Health will not review your appeal at this time.

This dismissal will not affect any determinations made after the appeal request.

## **If You Think Your Appeal Should Not Be Dismissed**

Under some circumstances, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing you also must state a good reason for us to do this.

If you ask us in writing to vacate this dismissal, NYSOH's Appeals Unit will review your request and send you a decision on that request.

If we deny your request to vacate this dismissal, we will tell you that in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by NYSOH.
