NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

Dear [REDACTED],

On December 15, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that You remained eligible for Medicaid, effective January 1, 2018. The notice further stated information showed you have other health insurance or Medicare and individuals who have such coverage cannot be enrolled in a Medicaid Managed Care plan. You appealed that determination.

On March 9, 2018, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and began your telephone hearing. During your hearing you stopped the proceeding and testified that since being found eligible for Medicaid as of January 1, 2018, you had already received medical services which were billed to Medicaid for that month by your doctor's office. You testified that you were not sure if you were successful with your appeal and had your Medicaid Managed Care plan backdated one month to January 1, 2018, whether those prior medical services would still be covered by your plan. You testified you were also not sure if your doctor accepts your Medicaid Managed Care plan or if medical bills were still outstanding. You decided that you would like to keep your current enrollment as it was with the start date of February 1, 2018 for your Medicaid Managed Care plan and Medicaid fee for service as of January 1, 2018.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
