## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your enrollment in an Essential Plan was effective February 1, 2018?

## Procedural History

On January 4, 2018, NY State of Health (NYSOH) issued a notice of eligibility determination, based on your January 3, 2018 application, stating that you were eligible to enroll in the Essential Plan, effective February 1, 2018.

Also on January 4, 2018, NYSOH issued a notice of enrollment, based on your plan selection on January 3, 2018, stating that you were enrolled in an Essential Plan with an enrollment start date of February 1, 2018.

On January 5, 2018, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in the Essential Plan insofar as it did not begin January 1, 2018.

On March 2, 2018, you were scheduled for a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. You requested that day that the hearing be adjourned to a later date.

On March 5, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. Under oath, you waived your right to formal notice of the

hearing. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on January 3, 2018.
- 2) You testified, and the record reflects, that you enrolled in an Essential Plan on January 3, 2018.
- 3) You testified that you wanted your enrollment in an Essential Plan to begin on [REDACTED] because on that date you had an accident requiring medical attention.
- 4) You testified that, about the time you submitted your application, you called Medicaid and someone there informed you that your insurance would be active within a few days of your first payment. You also testified that someone at the insurance provider for your Essential Plan might have told you that you would be able to obtain coverage for the month of January 2018, but you were not certain.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last

day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

## **Legal Analysis**

The issue is whether NYSOH properly determined that your enrollment in the Essential Plan was effective February 1, 2018.

You testified, and the record indicates, that you submitted your NYSOH application on January 3, 2018. As a result, you were found eligible for the Essential Plan as of January 3, 2018 and enrolled into a plan that day.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On January 3, 2018, you selected an Essential Plan, so your enrollment properly took effect on the first day of the first month following January; that is, on February 1, 2018.

Therefore, the January 4, 2018 enrollment confirmation notice stating that your enrollment in the Essential Plan was effective February 1, 2018, is correct and must be AFFIRMED.

## **Decision**

The January 4, 2018 enrollment confirmation notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your eligibility.

The effective date of your Essential Plan is February 1, 2018.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
