Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your enrollment in a silver-level qualified health plan was effective no earlier than February 1, 2018?

Procedural History

On October 17, 2017, NY State of Health (NYSOH) issued a renewal notice, stating that no action was required on your part because NYSOH had re-enrolled you in the same product you had before, a platinum-level qualified health plan at full cost, effective January 1, 2018. The notice further stated that changes needed to be made between November 16, 2017 and December 15, 2017. Finally, the notice stated that the cost for your plan coverage would be \$947.90 per month.

On November 18, 2017, NYSOH issued an enrollment confirmation notice, stating that you were enrolled in a platinum-level qualified health plan with a monthly premium responsibility of \$947.90, effective January 1, 2018.

On January 8, 2018, you submitted requests to NYSOH to disenroll from the platinum-level qualified health plan and enroll in a silver-level qualified health plan.

Also on January 8, 2018, you spoke to NYSOH's Account Review Unit and appealed insofar as your enrollment in the silver-level qualified health plan was effective February 1, 2018 and not January 1, 2018.

On January 9, 2018, NYSOH issued a disenrollment notice, stating that your enrollment in your platinum-level qualified health plan ended January 31, 2018.

On January 9, 2018, NYSOH issued an enrollment confirmation notice, stating that your enrollment in a silver-level qualified health plan was effective February 1, 2018.

On March 26, 2018, you were scheduled for a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. You requested that day that the hearing be adjourned to a later day.

On March 27, 2018, you had an adjourned telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. Under oath, you waived your right to formal notice of the hearing. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you receive notices from NYSOH by regular mail.
- 2) You testified that you did not receive either the October 17, 2017 renewal notice or the November 18, 2017 enrollment notice.
- 3) No notices sent to you at the address listed on your NYSOH account have been returned as undeliverable.
- 4) You testified that you first learned of the premium for the platinum-level qualified plan on January 2, 2018.
- 5) The record reflects, that you selected a silver-level qualified health plan on January 8, 2018.
- 6) You testified that you would have selected the silver-level plan earlier had you been notified of the premium responsibility amount for the platinum-level qualified health plan.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Annual Eligibility Redetermination

Generally, NYSOH must conduct annual eligibility redeterminations for qualified individuals who are seeking financial assistance through insurance affordability programs for the upcoming year, such as tax credits and cost-sharing reductions, Medicaid, or Child Health Plus. In such cases, NYSOH is required to request that the qualified individual provide updated income and family size information for use in an eligibility redetermination for the upcoming year (see 45 CFR § 155.335(a) and (b)).

NYSOH must send an annual renewal notice that contains the information by which NYSOH will use to redetermine a qualified individual's projected eligibility for that year (45 CFR § 155.335(c)(3)). If a qualified individual does not respond to the notice after a 30-day period, NYSOH must redetermine that individual's eligibility using the information and projected eligibility provided in the annual renewal notice (45 CFR § 155.335(g), (h)). NYSOH must ensure this redetermination is effective on the first day of the coverage year or in accordance with the rules specified in 45 CFR § 155.330(f) regarding effective dates, whichever is later (45 CFR § 155.335(i)). The rules specified in 45 CFR § 155.330(f) are not pertinent here.

Enrollment in a Qualified Health Plan

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in a silver-level qualified health plan was effective no earlier than February 1, 2018.

NYSOH must redetermine a qualified individual's eligibility for health insurance and financial assistance to help pay for that health insurance annually. NYSOH must issue a renewal notice that contains the individual's projected eligibility. If an individual does not respond to this notice, NYSOH must issue an eligibility determination for the upcoming coverage year based on the information contained in the renewal notice.

On October 17, 2017, NYSOH issued an annual renewal notice in your case. That notice stated that no action was required on your part and that you were re-enrolled in a platinum-level qualified health plan at full cost of \$947.90, effective January 1, 2018. The notice further stated that changes needed to be made between November 16, 2017 and December 15, 2017. On November 18, 2017, NYSOH issued an enrollment confirmation notice, stating that you were enrolled in a platinum-level qualified health plan with a monthly premium responsibility of \$947.90, effective January 1, 2018.

Because there were no timely responses to these notices, your enrollment in the platinum-level qualified health plan with a monthly premium responsibility of \$947.90 was effective January 1, 2018.

You testified that you did not receive any notices from NYSOH informing you of the premium responsibility for your platinum-level qualified health plan for 2018. You testified, and your NYSOH account confirms, that you elected to receive notifications by regular mail. However, there is no evidence in the record that any of the notices that were sent to your mailing address were returned as undeliverable.

Therefore, the record reflects that NYSOH properly notified you of the premium responsibility amount for the platinum-level qualified health plan that you were enrolled in, effective January 1, 2018, and the fact that you needed to make changes between November 16, 2017 and December 15, 2017.

The record shows that January 8, 2018 you submitted a request to enroll in a silver-level qualified health plan. On January 9, 2018, NYSOH issued an enrollment confirmation notice stating that your enrollment in your silver-level qualified health plan was effective February 1, 2018.

The date on which a qualified health plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected from the first day to and including fifteenth day of a month goes into effect on the first day of the following month.

Since you selected the silver level qualified health plan on January 8, 2018, your enrollment would properly begin on the first day of the next following month; that is on February 1, 2018.

Therefore, NYSOH's January 9, 2018 enrollment confirmation notice is **AFFIRMED** because it properly began your enrollment in your silver-level qualified health plan on February 1, 2018.

Decision

The January 9, 2018 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

Your enrollment in your silver-level qualified health plan properly began as of February 1, 2018.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
