## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were eligible to receive up to \$209.00 per month in advance payments of the premium tax credit (APTC), effective January 1, 2018?

Did NYSOH properly determine that you were eligible for cost-sharing reductions?

## Procedural History

On December 14, 2017, you renewed your application for health insurance and financial assistance through NYSOH for 2018.

Also on December 14, 2017, you uploaded income documentation to your NYSOH account as Document [REDACTED]. That day, NYSOH reviewed document [REDACTED] and determined it was sufficient to verify your household's income. NYSOH recalculated your household income based on this documentation, updated the income in your household's application based on this recalculation, and then submitted an application on your behalf.

On December 15, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to receive up to \$209.00 in APTC, as well as cost-sharing reductions if you enrolled in a silver level qualified health plan, both effective January 1, 2018.

On January 8, 2018, you spoke to NYSOH's Account Review Unit and appealed that eligibility determination notice insofar as you were not eligible for an increased amount of APTC.

On March 26, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and was held open until April 10, 2018, to allow you time to submit additional supporting documents.

On April 2, 2018, NYSOH received your supporting documents by fax. The documents were made part of the record as Appellant's Exhibit #1, and the record was closed.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You are seeking health insurance for yourself.
- 2) You testified that you expect to file your tax return for 2018 with a tax filing status of head of household and will claim two dependents on that tax return.
- 3) The December 14, 2017 application submitted by NYSOH on your behalf listed an annual household income of \$47,840.00, consisting of income you earn from employment.
- 4) NYSOH determined the income in your December 14, 2017 application based on paystubs you submitted for yourself that same day (see Document [REDACTED]).
- 5) You testified that the household income entered by NYSOH was incorrect because you believe that your net income minus your living expenses, such as housing payments, should be used in determining your eligibility for financial assistance as it more accurately reflects your income.
- 6) You testified that you consistently work 40 hours per week, and earn \$23.00 per hour. You provided additional documentation that confirms your testimony (see Appellant's Exhibit #1).
- 7) Your application states that you will not be taking any deductions on your 2018 tax return.
- 8) Your application states that you live in Queens County, NY.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Advance Payments of Premium Tax Credit

APTC are generally available to a person who is eligible to enroll in a qualified health plan and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a qualified health plan, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 26 CFR § 1.36B-2, 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

- 1) the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

*minus*

- 2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2018 is set by federal law at 2.01% to 9.56% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3, IRS Rev. Proc. 2017-36).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2017 FPL, which is \$20,420.00 for a three-person household (82 Federal Register 8831).

For annual household income in the range of at least 200% but less than 250% of the 2017 FPL, the expected contribution in 2018 is between 6.34% and 8.1% of the household income (26 CFR § 1.36B-3(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2017-36).

People who use the APTC to help pay health insurance premiums must file a federal tax return and reconcile their expected income (stated on NYSOH application) with their actual income (stated on their federal income tax return). Those who take less tax credit in advance than they claim on the tax return may get the rest of it as an income tax refund or have their tax bill reduced. Those who take more tax credit in advance than they can claim on their tax return will owe the difference as additional income taxes (26 CFR § 1.36B-4).

### Cost-Sharing Reductions

Cost-sharing reductions are available to a person who (1) is eligible to enroll in a qualified health plan through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level qualified health plan (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

### Modified Adjusted Gross Income

NYSOH bases its eligibility determinations on modified adjusted gross income as defined in the federal tax code (45 CFR § 155.300(a)). The term “modified adjusted gross income” means adjusted gross income increased by (1) any income that was excluded under 26 USC § 911 for United States citizens or residents living abroad, (2) tax-exempt interest received or accrued, and (3) Social Security benefits that were excluded from gross income under 26 USC § 86 (see 26 USC § 36B(d)(2)(B), 26 CFR § 1.36B-1(e)(2)).

“Adjusted gross income” means, in the case of an individual taxpayer, gross federal taxable income minus certain specific deductions, such as expenses reimbursed by an employer, losses from sale or exchange of property, losses from premature withdrawal of funds from time savings accounts, deductions attributable to royalties, and certain retirement savings (26 USC § 62(a)). Living expenses, such as rent and utilities are not an allowable deduction in computing adjusted gross income.

## **Legal Analysis**

The first issue under review is whether NYSOH properly determined that you were eligible for up to \$209.00 per month in APTC.

On December 14, 2017, you uploaded income documentation to your NYSOH account. That same day, a NYSOH representative reviewed the income documentation you submitted and recalculated your household income based on that documentation. An application for financial assistance was then submitted on your behalf, which listed an annual household income of \$47,840.00.

During the hearing, you testified that the amount entered by NYSOH in your application was incorrect. You testified that you believe your net income minus your living expenses, such as housing payments, should be used in determining your eligibility for financial assistance because you believe it more accurately reflects your household income.

The Internal Revenue Service rules do not allow living expenses such as the ones you asked to be deducted from the calculation of your adjusted gross income. Therefore, they cannot be deducted when NYSOH computes your modified adjusted gross income for financial assistance purposes. Furthermore, under current regulation, NYSOH must use your gross income before taxes are deducted, not net income, when determining your household's modified adjusted gross income.

You testified, and provided documentation, that you work 40 hours per week and earn \$23.00 per hour, or \$920.00 per week (see Document [REDACTED]; and Appellant's Exhibit #1). Since there are 52 weeks in a year, and you earn \$920.00 per week, NYSOH correctly determined your gross annual household income is \$47,840.00.

You are in a three-person household for purposes of this analysis. This is because you expect to file your 2018 income tax return as head of household and will claim two dependents on that tax return.

You reside in Queens County, where the second lowest cost silver plan available for an individual through NYSOH costs \$509.30 per month.

An annual income of \$47,840.00 is 234.28% of the 2017 FPL for a three-person household. At 234.28% of the FPL, the expected contribution to the cost of the health insurance premium in 2018 is 7.54% of income, or \$300.59 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for an individual in your county (\$509.30 per month) minus your expected contribution (\$300.59 per month), which equals \$208.71 per month. Therefore, rounding to the nearest dollar, NYSOH correctly determined you to be eligible for up to \$209.00 per month in APTC.

The second issue under review is whether you were properly determined eligible for cost-sharing reductions. Cost-sharing reductions are available to a person who has a household income no greater than 250% of the FPL. Since a household income of \$47,840.00 is 234.28% of the applicable FPL, NYSOH correctly found you to be eligible for cost sharing reductions.

Since the December 15, 2017 eligibility determination notice properly stated that, based on the information you provided, you were eligible for up to \$209.00 per

month in APTC and eligible for cost-sharing reductions, it is correct and is AFFIRMED.

The December 15, 2017 eligibility determination notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

You were properly determined eligible for up to \$209.00 in APTC in 2018.

You are properly determined eligible for cost-sharing reductions in 2018.

## **If You Disagree with this Decision (Appeal Rights)**

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
