

#### Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you and your spouse's enrollment in an Essential Plan was effective February 1, 2018?

## Procedural History

On January 8, 2018, NYSOH received your updated application for health insurance. That day, a preliminary eligibility determination was prepared stating that you and your spouse were eligible for the Essential Plan, for a limited time. Also that day, you enrolled you and your spouse into Essential Plans.

Also on January 8, 2018, you spoke to NYSOH's Account Review Unit and appealed the start date of the Essential Plan, insofar as you and your spouse were not covered for the month of January 2018.

On January 9, 2018, NYSOH issued a notice of eligibility determination, based on your January 8, 2018 application, stating that you and your spouse were eligible to enroll in the Essential Plan, for a limited time, effective February 1, 2018.

Also on January 9, 2018, NYSOH issued a notice of enrollment, based on your plan selection on January 8, 2018, stating that you and your spouse were enrolled in Essential Plans, and that your plans would start February 1, 2018.

On February 27, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

### **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on January 8, 2018.
- 2) You testified, and the record reflects, that you and your spouse enrolled in an Essential Plan on January 8, 2018.
- 3) You testified that you wanted you and your spouse's enrollment in an Essential Plan to begin on January 1, 2018 because you incurred medical bills in the month of January 2018.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

#### Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

## Legal Analysis

The issue is whether NYSOH properly determined that you and your spouse's enrollment in the Essential Plan was effective February 1, 2018.

You testified, and the record indicates, that you submitted your NYSOH application on January 8, 2018. As a result, you and your spouse were found eligible for the Essential Plan, for a limited time, as of February 1, 2018 and you both enrolled into a plan on that day.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On January 8, 2018, you selected an Essential Plan for yourself and your spouse, so the enrollment for both of you properly took effect on the first day of the first month following January 2018; that is, on February 1, 2018.

Therefore, the January 9, 2018 enrollment confirmation notice stating that you and your spouse's enrollment in the Essential Plan was effective February 1, 2018, is correct and must be AFFIRMED.

#### **Decision**

The January 9, 2018 enrollment notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change you or your spouse's eligibility.

The effective date of you and your spouse's Essential Health Plan is February 1, 2018.

## If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
