Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your enrollment in a qualified health plan, as well as the application of advance premium tax credits, was effective February 1, 2018?

Procedural History

On October 24, 2017, NY State of Health (NYSOH) issued a notice that it was time to renew your health insurance for the upcoming coverage year. That notice stated that, based on information from federal and state sources, NYSOH could not make a decision about whether you would qualify for financial help paying for your health insurance coverage, and that you needed to update your account by December 15, 2017 or you were at risk of losing your health insurance coverage and if applicable, any financial assistance.

On November 21, 2017, NYSOH issued a disenrollment notice, stating that your coverage with your qualified health plan would end on December 31, 2017.

No updates were made to your account by December 15, 2017.

On January 2, 2018, NYSOH received your updated application for financial assistance with health insurance.

On January 3, 2018, NYSOH issued a notice of eligibility redetermination, based on your January 2, 2018 application, stating that you were eligible to receive up

to \$321.00 per month in advance payment of the premium tax credit (APTC) for a limited time. This eligibility was effective February 1, 2018.

On January 3, 2018, NYSOH issued an enrollment confirmation notice, based on a plan selection made January 2, 2018, stating that you were enrolled in a qualified health plan with a monthly premium responsibility of \$288.43, after your APTC of \$321.00 was applied, effective February 1, 2018.

On January 8, 2018, you spoke to NYSOH's Account Review Unit and appealed insofar as the enrollment start date for your qualified health plan began February 1, 2018 and not January 1, 2018.

On March 8, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you did not recall how you elected to receive notices from NYSOH.
- 2) Your NYSOH account indicates that you receive notices from NYSOH by regular mail.
- 3) You testified that you did not receive any notices from NYSOH telling you that you needed to update the information in your NYSOH account by December 15, 2017 so that NYSOH could make an appropriate decision and that you were at risk of losing your health insurance coverage and if applicable, any financial assistance if you did not update your account.
- 4) No notices sent to you at the address listed on your NYSOH account have been returned as undeliverable.
- 5) You testified that you did not know you needed to renew your application until
- 6) You testified that you updated the information in your NYSOH account on January 2, 2018. That day you also selected a qualified health plan.
- 7) You testified that you have medical bills for the month of January 2018 when you were without health insurance coverage.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Annual Eligibility Redetermination

Generally, NYSOH must conduct annual eligibility redeterminations for qualified individuals who are seeking financial assistance through insurance affordability programs for the upcoming year, such as tax credits and cost-sharing reductions, Medicaid, or Child Health Plus. In such cases, NYSOH is required to request that the qualified individual provide updated income and family size information for use in an eligibility redetermination for the upcoming year (see 45 CFR § 155.335(a) and (b)).

NYSOH must send an annual renewal notice that contains the information by which NYSOH will use to redetermine a qualified individual's projected eligibility for that year (45 CFR § 155.335(c)(3)). If a qualified individual does not respond to the notice after a 30-day period, NYSOH must redetermine that individual's eligibility using the information and projected eligibility provided in the annual renewal notice (45 CFR § 155.335(g), (h)). NYSOH must ensure this redetermination is effective on the first day of the coverage year or in accordance with the rules specified in 45 CFR § 155.330(f) regarding effective dates, whichever is later (45 CFR § 155.335(i)). The rules specified in 45 CFR § 155.330(f) are not pertinent here.

Redetermination During a Benefit Year

When an eligibility redetermination results in a change in the amount of APTC for a part of the benefit year, NYSOH must recalculate the amount of APTC in such a manner as to account for any advance payments already made (or not made) on behalf of the tax filer, such that the recalculated advance payment amount is projected to result in total advance payments for the benefit year that correspond to the tax filer's total projected premium tax credit for the overall benefit year (45 CFR § 155.330(g)).

Any change resulting from redeterminations during a benefit year should be made effective the first day of the month following the date of the notice of redetermination, except that redeterminations resulting from changes made after a date specified by the state, which can be no earlier than the 15th of the month, may not be made effective until the first day of the month after the month following the date of the notice of redetermination. (45 CFR § 155.330(f)(1) and

(2). New York has specified that changes made after the 15th of a given month will take effect the month after the following month.

Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in a qualified health plan as well as your eligibility for APTC was effective February 1, 2018.

NYSOH must redetermine a qualified individual's eligibility for health insurance and financial assistance to help pay for that health insurance annually. NYSOH must issue a renewal notice that contains the individual's projected eligibility. If an individual does not respond to this notice, NYSOH must issue an eligibility determination for the upcoming coverage year based on the information contained in the renewal notice.

On October 24, 2017, NYSOH issued an annual renewal notice in your case. That notice stated that based on information from federal and state sources, NYSOH could not make a decision about whether or not you would qualify for financial help with paying for your health coverage. You were asked to update the information in your account by December 15, 2017, and that you were at risk of losing your health insurance coverage and if applicable, any financial assistance if you did not.

Because there was no timely response to this notice, your eligibility for financial assistance and your enrollment in a qualified health plan was terminated effective December 31, 2017.

You testified that you did not receive any notice from NYSOH telling you that you needed to update the information in your NYSOH account. Although you testified that you did not recall how you elected to receive notices from NYSOH, your account confirms that you elected to receive notifications by regular mail. However, there is no evidence in the record that any of the notices that were sent to your mailing address were returned as undeliverable.

Therefore, the record reflects that NYSOH properly notified you of your annual renewal and that information in your NYSOH account needed to be updated in order to ensure your enrollment in your health plan and eligibility for financial assistance would continue.

The record shows that on January 2, 2018, you updated the information in your NYSOH account and submitted a request to enroll in a qualified health plan.

When an individual changes information in their application on or before the 15th of any month, NYSOH must make the redetermination that results from the

change effective the first day of the following month. Additionally, the date on which a qualified health plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected from the first day to an including the fifteenth day of a month goes into effect on the first day of the following month.

Therefore, NYSOH's January 3, 2018 enrollment confirmation notice is AFFIRMED because it properly began your enrollment in your qualified health plan, as well as your APTC, on February 1, 2018.

Decision

The January 3, 2018 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

Your enrollment in your qualified health plan, and your eligibility for APTC, properly began as of February 1, 2018.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
