Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were eligible for the Essential Plan with a \$20.00 monthly premium, effective January 1, 2018?

Did NY State of Health properly determine that you were not eligible for Medicaid?

Procedural History

On November 16, 2017, you renewed your application for health insurance and financial assistance through NYSOH.

On November 17, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to enroll in the Essential Plan with a \$20.00 monthly premium, effective January 1, 2018. That notice also stated that you were not eligible for Medicaid because your annual household income was over the allowable income limits for that program.

Also on November 17, 2017, NYSOH issued a plan enrollment notice stating that you were enrolled in an Essential Plan, effective January 1, 2018.

On January 11, 2018, you spoke to NYSOH's Account Review Unit and appealed that eligibility determination notice insofar as you were not eligible for Medicaid.

On January 26, 2018, NYSOH issued a notice stating that you were eligible for Medicaid for a limited time, effective January 1, 2018. This was because you had been granted Aid to Continue pending the outcome of your appeal.

Also on January 26, 2018, NYSOH issued a plan enrollment notice stating that you were enrolled in a Medicaid Managed Care plan, effective January 1, 2018.

On March 15, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and held open until April 6, 2018, to allow you time to submit supporting income documents and proof of your dependents.

As of April 6, 2018, the Appeals Unit did not receive any documents from you and none were viewable in your NYSOH account. Therefore, the record was closed that same day and this decision is based on the record as developed at the time of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You are seeking health insurance for yourself.
- 2) Your November 16, 2017 application states that you expect to file your tax return for 2018 with a tax filing status of single and that you will claim one dependent on your tax return.
- 3) You testified that this is incorrect, and that you will claim two dependents on your tax return.
- 4) The application submitted on November 16, 2017, lists an expected annual household income of \$26,000.00, consisting of income you earn from employment.
- 5) You testified this is incorrect, and that you earn less than \$26,000.00.
- 6) Your application states that you will not be taking any deductions on your 2018 tax return.
- 7) Your application states that you live in Monroe County, NY.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable FPL or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application that was the 2017 FPL, which is \$16,240.00 for a two-person household (82 Federal Register 8831).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage; therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$16,240.00 for a two-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Legal Analysis

The first issue under review is whether NYSOH properly determined you were eligible for the Essential Plan with a \$20.00 monthly premium, beginning January 1, 2018.

The Essential Plan is generally provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution.

In your November 16, 2017 application you affirmed that your annual household income is \$26,000.00, and that you expect to file your 2018 tax return as single, claiming one dependent. NYSOH relied upon this information and determine your eligibility based on a two-person household with an annual income of \$26,000.00.

On the date of your November 16, 2017 application, the relevant FPL was \$16,240.00 for a two-person household. Since an annual household income of \$26,000.00 is 160.10% of the 2017 FPL, NYSOH correctly found you to be eligible for the Essential Plan with a \$20.00 monthly premium.

The second issue under review is whether NYSOH properly determined that you were not eligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$16,240.00 for a two-person household. Since \$26,000.00 is 160.10% of the 2017 FPL, NYSOH properly found you are not eligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, you testified that the information in your November 16, 2017 application was incorrect because your income is less than \$26,000.00, and that you claim two dependents on your tax return. The Hearing Officer allowed you time to submit proof of your household income and the number of dependents you claim on your tax return. As of the close of the record, no documentation was received. Therefore, there the record does not contain sufficient documentation to disturb the November 17, 2017 eligibility determination.

Since the November 17, 2017 eligibility determination notice properly stated that, based on the information you provided, you were eligible for the Essential Plan with a \$20.00 monthly premium, and not eligible for Medicaid, it is correct and is AFFIRMED.

Decision

The November 17, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You were properly determined to be eligible for the Essential Plan with a \$20.00 monthly premium, as of January 1, 2018.

You were properly determined to be ineligible for Medicaid.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
