#### ssue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that the enrollment of you, your spouse, and your two oldest children in a Medicaid Managed Care plan was effective February 1, 2018?

## **Procedural History**

On January 12, 2018, NYSOH received your initial application for financial assistance with health insurance. In response to this application, NYSOH prepared a preliminary eligibility determination stating that you were eligible for a Medicaid, effective January 1, 2018.

Also on January 12, 2018, your NYSOH enrollment details reflected your selection of an Medicaid Managed Care (MMC) plan for the coverage of you, your spouse, and your two oldest children as of January 12, 2018, with such coverage beginning February 1, 2018.

Finally, on January 12, 2018, you spoke to NYSOH's Account Review Unit and appealed the start date of the enrollment of you, your spouse, and your two oldest children in an MMC plan, insofar as it did not begin on January 1, 2018.

On January 13, 2018, NYSOH issued a notice of eligibility determination, based on your January 12, 2018 application, stating that you, your spouse, and your two oldest children were eligible for Medicaid, effective January 1, 2018.

Also on January 13, 2018, NYSOH issued an enrollment notice confirming your selection of an MMC plan as of January 12, 2018 for the coverage of you, your spouse, and your two oldest children, with such coverage beginning effective February 1, 2018.

On March 7, 2018, your spouse, (acting on your behalf as your Authorized Representative), had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- NYSOH received your initial application for financial assistance with health insurance for you, your spouse, and your two oldest children on January 12, 2018.
- You spouse testified, and the record reflects, that you first selected the MMC plan for you, your spouse, and your two oldest children on January 12, 2018, and that your family's enrollment was effective on February 1, 2018.
- 3) Your spouse testified that you wanted your family's coverage under the MMC plan coverage to begin on January 1, 2018 because you had incurred considerable medical expenses relating to the birth of your newborn child on
- 4) Your spouse testified that your family had been enrolled in Medicaid through Sullivan County Department of Social Services (DSS) during 2017, but that the enrollment had been terminated effective December 31, 2017. Your spouse further testified that Sullivan County DSS did not notify you of the termination of your coverage, and had prevented you from accessing your NYSOH account.
- 5) Your spouse testified that you were seeking for your family's MMC plan coverage to begin no later than January 1, 2018.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

#### Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

### Legal Analysis

The issue is whether NYSOH properly determined that the enrollment of you, your spouse, and your two oldest children in the MMC plan was effective February 1, 2018.

Your spouse testified, and your NYSOH account reflects, that you contacted NYSOH on January 12, 2018 and enrolled you, your spouse, and your two oldest children into a MMC plan. Your spouse further testified your family had been enrolled in Medicaid through Sullivan County DSS, but that the enrollment had been terminated effective December 31, 2017. Finally, your spouse testified that Sullivan County DSS did not notify you of the termination of your coverage, and had prevented you from accessing your NYSOH account.

Your NYSOH account contains no record of your eligibility having been transferred from Sullivan County DSS. Furthermore, NYSOH has no control or obligation with respect to actions taken by DSS on your family's eligibility for either fee-for-service Medicaid or MMC enrollment.

The date on which an MMC plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On January 12, 2018, you selected an MMC plan for you, your spouse, and your two oldest children, so it properly took effect on the first day of the month following January 2018; that is, on February 1, 2018.

Therefore, the January 13, 2018 enrollment notice stating that the enrollment of you, your spouse, and your two oldest children in your MMC plan would be effective February 1, 2018, was correct and must be AFFIRMED.

#### **Decision**

The January 13, 2018 enrollment notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your family's eligibility.

The effective date of the MMC plan for you, your spouse, and your two oldest children is February 1, 2018.

## If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your appeal was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
