Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were not eligible for an advance payment of the premium tax credit (APTC), or cost-sharing reductions (CSR), effective March 1, 2018?

Procedural History

On January 16, 2018, you applied for health insurance and financial assistance through NYSOH.

That day, a preliminary eligibility determination was prepared stating that you were eligible to purchase a qualified health plan at full cost, effective March 1, 2018.

Also on January 16, 2018, you spoke to NYSOH's Account Review Unit and appealed that preliminary eligibility determination notice insofar as you were not eligible for financial assistance.

On January 17, 2018, NYSOH issued an eligibility determination notice stating that you were eligible to purchase a qualified health plan at full cost, effective March 1, 2018. That notice further stated that you were ineligible for financial assistance because APTC payments were made to your insurance company to reduce your premium costs in a prior year and NYSOH could not tell if you filed a federal tax return for that year.

On March 14, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and held open to March 28, 2018, to allow you time to submit supporting documents.

On March 20, 2018, NYSOH received your supporting documents by fax. The documents were made part of the record as Appellant's Exhibit #1. The record remained open until March 28, 2018, and was then closed.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on January 16, 2018.
- 2) You testified that your father electronically filed a tax return on your behalf in 2016.
- 3) You testified that your 2016 tax return was filed in April 2017, and that you did not require an extension.
- 4) You testified that you lived in [REDACTED] from 2006 to 2017, and that you received APTC in 2016 while residing in [REDACTED]
- 5) You submitted a copy of your 2016 Form 1040, an undated State of [REDACTED] Individual Income Tax Declaration for Electronic Filing, and 2016 Individual Income Tax Form 104.
- 6) You testified that as far as you know, all tax forms were properly filed and your APTC was reconciled in 2016.
- 7) According to your NYSOH account, you have not submitted a copy of your 2016 IRS tax transcript to NYSOH.
- 8) You testified that you are seeking financial assistance with health insurance.
- 9) Your application states that you live in Monroe County, NY.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Verification of Eligibility for Advance Payments of the Premium Tax Credit

APTC are generally available to a person who is eligible to enroll in a qualified health plan and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a qualified health plan, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

NYSOH may not determine a tax filer eligible for APTC if APTC was paid on the tax filer's behalf in a previous year, and a tax return was not filed for that previous year (45 CFR § 155.305(f)(4)).

An applicant is required to attest to their household's projected annual income for purposes of determining their eligibility for APTC (45 CFR § 155.320(c)(3)(ii)(B)). For all individuals, whose household income is needed, NYSOH must request tax return data from the Secretary of the Treasury and data regarding Social Security benefits from the Commissioner of Social Security to confirm that the information the applicant is attesting to is accurate (45 CFR § 155.320(c)(1)(i); 45 CFR § 155.320(c)(3)(ii)(A)).

If income data is unavailable, or if an applicant's attestation is not reasonably compatible with the income data NYSOH obtains, NYSOH must request additional information from the applicant to resolve the inconsistency (45 CFR § 155.320 (c)(3)(iii), (iv)).

NYSOH must provide the applicant with notice of the inconsistency in their account and 90 days to provide satisfactory documentary evidence to resolve the inconsistency (45 CFR § 155.315 (f)(2)). If NYSOH remains unable to verify the attestation of the applicant, NYSOH must redetermine the applicant's eligibility based on the information available from the data sources unless the applicant demonstrates that they are unable to provide the required documentation (45 CFR § 155.315(f)(2), (g)).

Upon making an eligibility redetermination, NYSOH must notify the applicant and implement any changes in eligibility to APTC effective as of the first day of the month following the date of the notice (45 § 155.310(f), 45 CFR § 155.330(e), (f)(1)(i)).

Cost-Sharing Reductions

Cost-sharing reductions (CSR) are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, If you need this information in a language other than English or you need assistance reading this notice, we can help you. (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you were not eligible to receive APTC or CSR, effective March 1, 2018.

The record shows that on January 16, 2018, you updated the information in your NYSOH account and submitted a request for financial assistance. NYSOH then issued an eligibility determination notice that in part stated that you were ineligible for financial assistance. The notice further stated that this was because you received APTC in the past and NYSOH was unable to tell if you filed your tax return or properly reconciled your taxes for the prior year.

You testified that your father electronically filed a tax return on your behalf in 2016, that your 2016 tax return was filed in April 2017, and that you did not require an extension. You testified that you lived in [REDACTED] from 2006 to 2017, and that you received APTC in 2016 while residing in [REDACTED]. You submitted a copy of your 2016 1040, an undated State of [REDACTED] Individual Income Tax Declaration for Electronic Filing, and 2016 [REDACTED] Individual Income Tax Form 104. You testified that as far as you know, all tax forms were properly filed and your APTC was reconciled in 2016.

At the time of your January 16, 2018 application, NYSOH had not received information from the IRS that your household's tax returns for 2016 had been properly filed and reconciled. If NYSOH is unable to obtain information that a prior year's tax return has been filed and APTC received has been reconciled, NYSOH may not determine a tax filer eligible for APTC, if APTC was paid on the tax filer's behalf in a previous year.

Although NYSOH received a client copy of your 2016 Form 1040, NYSOH did not receive your 2016 IRS tax transcript confirming that your taxes had been properly filed and APTC had been reconciled. Thus, NYSOH could not determine you eligible for APTC at the time of your application for the 2018 coverage year.

Since NYSOH found that you did not meet the requirements to receive APTC, which is required to be eligible for CSR, it follows that NYSOH properly determined you to be ineligible for CSR also.

Since there is insufficient information in the record to determine whether you filed and properly reconciled your 2016 tax return, the January 17, 2018 eligibility

determination notice finding you eligible to purchase a qualified health plan at full cost and ineligible for APTC or CSR, effective March 1, 2018, is AFFIRMED.

Decision

The January 17, 2018 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You were not eligible for APTC and CSR effective March 1, 2018.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
