Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in a qualified health plan with dental coverage was effective no earlier than February 1, 2018?

Procedural History

On December 15, 2017, you submitted a non-financial application for health insurance with NYSOH.

On December 16, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible for a full cost qualified health plan. This eligibility was effective January 1, 2018.

Also on December 16, 2017, NYSOH issued a letter confirming your enrollment in a qualified health plan with a monthly premium responsibility of \$567.29, effective January 1, 2018.

On January 12, 2018, you selected a qualified health plan with dental coverage.

On January 13, 2018, NYSOH issued a letter confirming your enrollment in a qualified health plan with a dental coverage with premium responsibility of \$605.74, effective February 1, 2018.

On January 15, 2018, you spoke to NYSOH's Account Review Unit and appealed the enrollment confirmation notice insofar as it began your enrollment in a dental plan on February 1, 2018, and not January 1, 2018.

On April 3, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You applied to NYSOH for health insurance, declining financial assistance, on December 15, 2017.
- 2) You enrolled in a qualified health plan with a monthly premium of \$567.29, effective January 1, 2018.
- 3) You testified, and the record reflects, that you selected a qualified health plan with dental coverage on January 12, 2018.
- 4) Your enrollment in the qualified health plan with dental coverage became effective February 1, 2018.
- 5) You testified that you need your qualified health plan with dental coverage to begin on January 1, 2018 because you have a dental bill from January 2018.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Enrollment in a Qualified Health Plan

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in a qualified health plan, with dental coverage, was effective no earlier than February 1, 2018.

You applied to NYSOH for health insurance, declining financial assistance, on December 15, 2017. You enrolled in a qualified health plan with a monthly premium of \$567.29, effective January 1, 2018.

The record shows that on January 12, 2018 you selected a qualified health plan with dental coverage. On January 13, 2018, NYSOH issued an enrollment confirmation notice stating that your enrollment in your qualified health plan with dental coverage was effective February 1, 2018.

The date on which a qualified health plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected from the first day to and including fifteenth day of a month goes into effect on the first day of the following month. For selections from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month.

Since you selected a qualified health plan with dental coverage on January 12, 2018, your plan was effective on the first day of the next month; that is, on February 1, 2018.

Therefore, NYSOH's January 13, 2018 enrollment confirmation notice is **AFFIRMED** because it properly began your enrollment in your qualified health plan with dental coverage on February 1, 2018.

Decision

The January 13, 2018 enrollment confirmation notice is **AFFIRMED**.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
