Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were not eligible for Medicaid for the month of December 2017?

Procedural History

On January 5, 2018, you submitted an application for financial assistance with health insurance and indicated that you were seeking help for paying for medical bills for the prior three months.

That same day, NYSOH prepared a preliminary eligibility determination stating that in order for your eligibility to be determined, you were required to submit documentation to confirm the information in your application.

Also on January 5, 2018, you submitted income documentation.

On January 6, 2018, NYSOH issued a notice stating that the income information in your application did not match what NYSOH received from state and federal data sources. You were directed to provide proof of income by January 20, 2018, so that your eligibility could be determined.

On January 8, 2018, NYSOH verified that your documentation was sufficient proof of income and an application was run on your behalf.

On January 9, 2018, NYSOH issued an eligibility determination notice stating that you were eligible for Medicaid, effective as of January 1, 2018.

Also on January 9, 2018, NYSOH issued an eligibility determination notice stating that you were not eligible for Medicaid for December 2017, because your monthly household income of \$1,390.00 was over the allowable monthly income limit of \$1,387.00.

On January 17, 2018, you spoke to NYSOH's Account Review Unit and appealed that eligibility determination notice insofar as you were denied retroactive Medicaid for the month of December 2017.

On March 21, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing held open to April 4, 2018, to allow you to submit supporting documents.

As of April 4, 2018, the Appeals Unit did not receive any documents from you and none were viewable in your NYSOH account. Therefore, the record was closed that same day and this decision is based on the record as developed at the time of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are seeking Medicaid for December 2017.
- 2) You testified that you expect to file your 2017 federal income tax return as single, and claim no dependents.
- 3) You submitted an application for financial assistance on January 5, 2018.
- 4) Your application submitted on January 5, 2018, states that for the month of December 2017 your income was \$1,390.00. You testified that you could not confirm this amount.
- 5) You testified that you are paid weekly.
- 6) You submitted a copy of your 2017 W2 forms, which state that you earned \$18,450.70 at [REDACTED] and \$1,702.50 at [REDACTED].
- 7) You submitted a copy of what appears to be your December 2017 Employee Earnings Record, which is not legible.

- 8) You testified that you do not plan on taking any deductions on your tax return

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid for Adults between the Ages of 19 and 65

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$12,060.00 annually, or \$1,387.00 monthly, for a one-person household (82 Federal Register 8831).

Retroactive Medicaid

The Department of Health must make Medicaid coverage start retroactively for up to three months prior to the month of an initial application if the individual received medical services that would have been covered under Medicaid and the individual would have been eligible for Medicaid at the time he received the services if he had applied (42 USCA § 1396A(34); 42 CFR § 435.915(a)). The Department of Health may make eligibility effective for fee-for-service Medicaid on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you were not eligible for Medicaid for December 2017.

You are in a one-person household for purposes of this analysis, because you file your taxes with a tax filing status of single and claim no dependents on your tax return.

You submitted an application for financial assistance on January 5, 2018 and requested help in paying for medical bills for December 2017. You testified that you are seeking Medicaid for December 2017.

When an individual files an initial application for Medicaid, his or her eligibility for retroactive Medicaid depends on the date of application. To this end, it does not matter whether or not that initial application resulted in Medicaid going forward. Instead, an individual, who has filed an initial application for Medicaid through NYSOH, has the right to be evaluated for Medicaid for the three months before the month of his or her application.

Medicaid coverage can be made effective retroactively for up to three months prior to an individual's initial application if the individual received medical services that would have been covered under Medicaid and if they would have been eligible for Medicaid in those three months had they applied.

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size. To be eligible for Medicaid in December 2017, you would have needed to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,387.00 per month. There is no indication in the record that you would have been ineligible for Medicaid based on non-financial criteria during December 2017.

You testified that you are paid weekly. You submitted a copy of your 2017 W2 forms, which states that you earned \$18,450.70 at [REDACTED] and \$1,702.50 at [REDACTED]. You also submitted a copy of what appears to be your December 2017 Employee Earnings Record, which is not legible. You did not submit any documentation following the hearing as directed. Therefore, there is insufficient documentation in the record to modify your December 2017 earnings as stated in your January 5, 2018 application. The record therefore indicates that in the month of December 2017, you had a monthly household income of \$1,390.00.

Since your income of \$1,390.00 was more than the \$1,387.00 monthly Medicaid limit for December 2017, NYSOH properly determined that you were not eligible for Medicaid coverage during that month.

Therefore, the January 9, 2018 eligibility determination notice stating that you were not eligible for Medicaid in the month of December 2017, is correct and is AFFIRMED.

Decision

The January 9, 2018 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You are not eligible for Medicaid in the month of December 2017, based on the record as developed at the time of hearing.

Your eligibility for Medicaid was effective as of January 1, 2018.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
