## NOTICE OF DISMISSAL

On December 28, 2017, NY State of Health (NYSOH) issued a plan enrollment notice, stating that you and your spouse were enrolled in Essential Plans with \$20.00 monthly premiums, effective February 1, 2018. You appealed this determination.

On February 28, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for March 21, 2018, at 10:00 a.m.

A Hearing Officer placed a call to the number that was listed on the Notice of Telephone Hearing [REDACTED] at 10:02 a.m. on March 21, 2018. A woman answered the phone and stated that now was not a good time, and disconnected the call.

At 10:10 a.m., the Hearing Officer placed a call to telephone number [REDACTED]. The automotive message stated that the number was for [REDACTED]. Since there is no authorized representative listed on the account, the Hearing Officer disconnected the telephone call before speaking with a representative.

The Hearing Officer attempted to contact you at the same telephone number at 10:15 a.m. and 10:30 a.m., but the telephone rang continuously and the Hearing Officer was unable to leave a message.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
