NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On January 18, 2018 and January 27, 2018, NY State of Health (NYSOH) issued a plan enrollment notices, stating that you and your children were enrolled in CDPHP, effective March 1, 2018. You appealed this determination.

On February 22, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for March 13, 2018, at 10:00 a.m.

On March 13, 2018, a Hearing Officer placed four calls to the telephone number that you provided to NYSOH, at 10:00 a.m., 10:01 a.m., 10:06 a.m. and 10:20 a.m. Although a female voice answered the initial telephone call, this call was disconnected after the Hearing Officer introduced herself. The Hearing Officer was unable to reach you in the next three attempts to return the telephone call.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
