Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your eligibility for and enrollment in an Essential Plan was effective March 1, 2018?

Procedural History

On January 17, 2018, you updated your NY State of Health (NYSOH) account and submitted an application for financial assistance with health insurance.

On January 18, 2018, NYSOH issued an eligibility determination notice, based on your January 17, 2018 application, stating that you were eligible to enroll in the Essential Plan, effective March 1, 2018.

Also on January 18, 2018 NYSOH issued an enrollment confirmation notice, based on your plan selection on January 17, 2018, stating that you were enrolled in an Essential Plan with vision and dental, with a premium of \$48.02, and that your plan would start March 1, 2018.

Finally, on January 18, 2018, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in the Essential Plan insofar as it did not begin January 1, 2018.

On March 27, 2018, you were scheduled for a telephone hearing. That day, a Hearing Officer called you to conduct your scheduled hearing. You requested

that your hearing be rescheduled for a later date. The Hearing Officer agreed to adjourn your hearing to March 30, 2018.

On March 30, 2018, you had your adjourned telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. During the hearing, you waived your right to formal notice on the record. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on January 17, 2018.
- 2) You testified, and the record reflects, that you enrolled in an Essential Plan on January 17, 2018.
- 3) You testified that you wanted your enrollment in an Essential Plan to begin on January 1, 2018.
- 4) You testified that you have medical bills from medical services received in January and February 2018.
- 5) You testified that you attempted to submit an application for health insurance over the phone in October 2017, and were told that you were not eligible at that time, and should reapply at a later date. You testified that you were not given a specific date to apply.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue is whether NYSOH properly determined that your eligibility for and enrollment in the Essential Plan was effective March 1, 2018.

You testified, and the record reflects, that you updated your NYSOH application on January 17, 2018. As a result, you were found eligible for the Essential Plan as of March 1, 2018. Also on January 17, 2018, you selected an Essential Plan for enrollment.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On January 17, 2018, you selected an Essential Plan, so your enrollment properly took effect on the first day of the second month following January; that is, on March 1, 2018.

Therefore, the January 18, 2018 eligibility determination notice stating that your eligibility for the Essential Plan was effective March 1, 2018, is correct, and must be AFFIRMED. The January 18, 2018 enrollment confirmation notice stating that your enrollment in the Essential Plan was effective March 1, 2018, is also correct and must be AFFIRMED.

Decision

The January 18, 2018 eligibility determination notice is AFFIRMED.

The January 18, 2018 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

The effective date of your Essential Health Plan is March 1, 2018.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
