Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that you were not eligible for retroactive Medicaid coverage for the month of November 2017?

Procedural History

On January 17, 2018, NY State of Health (NYSOH) received your updated application for financial assistance with health insurance which indicated, in part, that you were seeking help for paying for medical bills for November 2017.

On January 18, 2018, NYSOH issued an eligibility redetermination notice, based on the January 17, 2018 application, stating that you were eligible to enroll in the Essential Plan, effective March 1, 2018.

On January 22, 2018, you spoke to NYSOH's Account Review Unit and appealed insofar as you had not been determined eligible for retroactive Medicaid for November 2017.

On March 13, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. During the hearing [REDACTED] interpreted a portion of the hearing. The Interpreter hung up the phone and you requested that the hearing be completed in English. The record was developed during the hearing and left open for 15 days, to March 28, 2018, to allow you the opportunity to submit additional paystubs showing your wife's income for November 2017.

By March 20, 2018, you had uploaded to your NYSOH account the requested documentation and they were collectively marked as Appellant's Exhibit #1 and incorporated into the record. The record is now closed.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are seeking Medicaid for November 2017.
- 2) You testified that you expect to file your 2017 federal income tax return as married filing jointly, claim no dependents, and not take any deductions.
- 3) Your application submitted on January 17, 2018, states that for the month of November 2017 your income was \$0.00. You testified that amount was correct.
- 4) You uploaded your wife's paystubs covering the month of November 2017.
 - a. For the paystub with a deposit date of November 2, 2017, the gross pay was \$911.95.
 - b. For the paystub with a deposit date of November 16, 2017, the gross pay was \$803.20.
 - c. For the paystub with a deposit date of November 30, 2017, the gross pay was \$944.95.
- 5) You testified that your wife is paid every two weeks.
- 6) You testified that you received [REDACTED] and incurred medical bills in November 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

De Novo Review

NYSOH Appeals Unit must review each appeal de novo and "consider all relevant facts and evidence adduced during the appeals process" (45 CFR § 155.535(f)). "De novo review means a review of an appeal without deference to prior decisions in the case" (45 CFR § 155.500).

Medicaid for Adults between the Ages of 19 and 65

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the federal poverty level (FPL) for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual’s eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$16,240.00 for a two-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014). On the date of your application, the 2017 monthly FPL was \$1,354.00 for a two-person household (82 Fed. Reg. 8831).

In the case of a married couple living together, each spouse will be included in the household of the other spouse, regardless of whether they expect to file a joint tax return (42 CFR § 435.603(f)(4)).

Retroactive Medicaid

The Department of Health must make Medicaid coverage start retroactively for up to three months prior to the month of an initial application if the individual received medical services that would have been covered under Medicaid and the individual would have been eligible for Medicaid at the time he received the services if he had applied (42 USCA § 1396A(34); 42 CFR § 435.915(a)). The Department of Health may make eligibility effective for fee-for-service Medicaid on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you were not eligible for retroactive Medicaid coverage for the month of November 2017.

You testified that you are appealing the denial of retroactive Medicaid for yourself for November 2017. However, the record does not contain an eligibility

determination regarding your request for retroactive Medicaid for November 2017.

Here, the lack of an eligibility determination notice on the issue of retroactive Medicaid for the month of November 2017, does not prevent the Appeals Unit from reaching the merits of the case or constitute material error. Under 45 CFR § 155.505(b), you are as entitled to appeal NYSOH failure to timely issue an eligibility determination notice as you are to appeal an adverse eligibility determination notice.

Since the Appeals Unit review of NYSOH determinations is performed on a de novo basis, no deference would have been granted to the eligibility determination notice had it been issued.

You are in a two-person household; you file your taxes with a tax filing status of married filing jointly and claim no dependents on your tax return.

You submitted an updated application for financial assistance with health insurance on January 17, 2018 and requested help in paying for medical bills for November 2017.

When an individual files an initial application for Medicaid, his or her eligibility for retroactive Medicaid depends on the date of application. To this end, it does not matter whether or not that initial application resulted in Medicaid going forward. Instead, an individual, who has filed an initial application for Medicaid through NYSOH, has the right to be evaluated for Medicaid for the three months before the month of his or her application. Because November 2017 is within the three-month period prior to January 17, 2018, you have the right to be evaluated for retroactive Medicaid coverage.

Medicaid coverage can be made effective retroactively for up to three months prior to an individual's initial application if the individual received medical services that would have been covered under Medicaid and if they would have been eligible for Medicaid in those three months had they applied.

You testified that you received medical services and incurred medical bills in November 2017.

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

To be eligible for Medicaid in November 2017, you would have needed to meet the non-financial criteria and have a household income no greater than 138% of the 2017 FPL for a two-person household, which was \$1,868.52 per month in 2017. There is no indication in the record that you would have been ineligible for Medicaid based on non-financial criteria during November 2017.

You testified that had an income of \$0.00 for the month of November 2017. You testified that your wife is employed and is paid every two weeks. You uploaded your wife's paystubs covering the month of November 2017. For the paystub with a deposit date of November 2, 2017, the gross pay was \$911.95. For the paystub with a deposit date of November 16, 2017, the gross pay was \$803.20. For the paystub with a deposit date of November 30, 2017, the gross pay was \$944.95. Therefore, the record indicates that in the month of November 2017, you had a monthly household income of \$2,660.10.

Since your income of \$2,660.10 was more than the \$1,868.52 monthly Medicaid limit for November 2017, NYSOH properly determined that you were not eligible for Medicaid coverage during that month. Therefore, NYSOH was correct in denying retroactive Medicaid coverage for November 2017 and is AFFIRMED.

Decision

NYSOH was correct in denying retroactive Medicaid coverage for November 2017 and is AFFIRMED.

How this Decision Affects Your Eligibility

You are not eligible for Medicaid in the month of November 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
