lssues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly terminate your qualified health plan for non-payment of premium effective, January 1, 2018?

Did NYSOH properly determine that your re-enrollment in your qualified health plan was effective March 1, 2018?

Procedural History

On November 8, 2017, NYSOH issued an eligibility determination notice stating that you were conditionally eligible to purchase a qualified health plan at full cost, effective January 1, 2018.

Also on November 8, 2017, NYSOH issued a plan enrollment notice confirming your enrollment in a qualified health plan, effective January 1, 2018.

On November 18, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to purchase a qualified health plan at full cost, effective January 1, 2018.

On January 14, 2018, NYSOH issued a plan disenrollment notice stating that your enrollment in your qualified health plan was terminated, effective January 1, 2018, because the health plan did not receive a premium payment.

On January 19, 2018, you updated your application for financial assistance and selected a plan for enrollment.

On January 20, 2018, NYSOH issued a plan enrollment notice confirming your enrollment in a qualified health plan, effective March 1, 2018.

On January 22, 2018, you spoke to NYSOH's Account Review Unit and appealed the termination of your qualified health plan for the month of January 2018.

On March 22, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You were enrolled into a qualified health plan, effective January 1, 2018.
- 2) You testified that you paid your premium to your qualified health plan for January 2018, but that your qualified health plan rejected that payment and returned it to you because your spouse's name was on the check, and because the account number on the check was incorrect.
- 3) You were disenrolled from your qualified health plan, effective January 1, 2018.
- 4) You testified that you contacted your qualified health plan when you became aware that you had been disenrolled, but your plan refused to assist you, accept your premium payment for January 2018 or February 2018, and instructed you to contact NYSOH.
- 5) According to your NYSOH account and testimony, you contacted NYSOH on January 19, 2018, and re-enrolled in your qualified health plan, which began March 1, 2018.
- 6) You testified that you are seeking to have your enrollment in your qualified health plan begin January 1, 2018, because you incurred medical bills in January 2018 and February 2018.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Appealable Issues

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) an eligibility determination for an exemption; (4) a failure by NYSOH to provide timely notice of an eligibility determination 45 CFR § 155.505; and (5) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

Enrollment in a Qualified Health Plan

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The first issue under review is whether NYSOH properly terminated your qualified health plan for non-payment of premium effective, January 1, 2018.

You were enrolled into your qualified health plan on January 1, 2018. You testified that you paid your premium payment to you qualified heath plan for the month of January 2018, but that your qualified health plan rejected that payment and returned it to you because your spouse's name was on the check, and because the account number on the check was incorrect.

On January 14, 2018, NYSOH issued a notice stating that you were disenrolled from your qualified health plan for non-payment of premiums, effective January 1, 2018.

NYSOH Appeals Unit only has the authority to review issues related to the following: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (3) an eligibility

determination for an exemption, (4) a failure to provide timely notice of an eligibility determination and (5) a denial of a special enrollment period.

Since the Appeals Unit is not given the authority to review termination of enrollment due to non-payment of premiums, we cannot reach the merits as to whether or not you were properly terminated from your qualified health plan for non-payment of premiums. Therefore, your appeal of the January 14, 2018 plan disenrollment notice is DISMISSED as a non-appealable issue.

You testified that you have contacted your qualified health plan but your plan refused to assist you, accept your premium payment for January 2018 or February 2018, and instructed you to contact NYSOH. Therefore, referring you to your health plan would not be constructive.

The second issue under review is whether NYSOH properly determined that your re-enrollment in your qualified health plan was effective no earlier than March 1, 2018.

You contacted NYSOH on January 20, 201,8 and re-enrolled into a qualified health plan, effective March 1, 2018.

The date on which a qualified health plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since you contacted NYSOH and re-enrolled into a qualified health plan on January 20, 2018, your re-enrollment should take effect the first day of the second month after January 2018; that is, on March 1, 2018.

Therefore, the January 20, 2018 plan enrollment notice stating that your reenrollment in your qualified health plan was effective March 1, 2018, was correct and is AFFIRMED.

Decision

Your appeal of the insurer's termination of your enrollment in your qualified health plan for non-payment of premiums, effective January 1, 2018, is DISMISSED as a non-appealable issue.

The January 20, 2018 plan enrollment notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your eligibility for or enrollment in a qualified health plan.

Your re-enrollment in a qualified health plan was effective March 1, 2018.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
