Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that you were eligible to receive up to \$407.00 per month in advance payments of the premium tax credit, effective January 1, 2018?

Did NY State of Health properly determine that you were eligible for costsharing reductions?

Did NY State of Health properly determine that you were not eligible for the Essential Plan?

Did NY State of Health properly determine that you were not eligible for Medicaid?

Procedural History

On November 26, 2017, NY State of Health (NYSOH) received your updated application for financial assistance with health insurance.

On November 27, 2017, NYSOH issued an eligibility determination notice stating that you were eligible for a limited time to receive up to \$407.00 per month in advance payments of the premium tax credit (APTC), as well as cost-sharing reductions if you enrolled in a silver level qualified health plan, both effective January 1, 2018. That notice also stated that you were not eligible for Medicaid or the Essential Plan because your annual household income was over the

allowable income limits for those programs. However, the notice also stated that NYSOH sent your information to your local Department of Social Services to determine your eligibility for Medicaid on a different basis. The notice directed you to submit income documentation by February 24, 2018 to confirm your eligibility.

Also on November 27, 2017, NYSOH issued a plan enrollment notice confirming your enrollment in a silver-level qualified health plan with the application of your APTC, both effective January 1, 2018.

On December 6, 2017, you faxed one income document to NYSOH, which was uploaded to your NYSOH account on December 7, 2017.

On December 7, 2017, a NYSOH representative validated your income documentation and a completed application was submitted on your behalf.

On December 8, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to receive up to \$407.00 per month in APTC and eligible for cost-sharing reductions if you enrolled into a silver-level qualified health plan, both effective January 1, 2018. This notice further stated that you were not eligible for Medicaid or the Essential Plan because your annual household income was over the allowable income limits for those programs. This notice stated that your information was sent to your local Department of Social Services on November 26, 2017, to determine your eligibility for Medicaid on a different basis.

On January 22, 2018, you spoke to NYSOH's Account Review Unit and appealed that eligibility determination notice insofar as you were not eligible for a more affordable health insurance program.

On March 21, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your tax return for 2018 with a tax filing status of single. You will claim no dependents on that tax return.
- 2) You are seeking health insurance for yourself.
- 3) The application that was submitted on December 7, 2017 listed annual household income of \$24,364.00, consisting of \$23,064.00 you receive

from Social Security Disability benefits and \$1,300.00 you receive in taxable IRA distributions. You testified that this amount was correct.

- 4) You testified that you receive your IRA distributions every three months throughout the year.
- 5) You testified that you are unsure as to whether you received a payment from your IRA in the month of December 2017.
- 6) You testified, and provided documentation to show, that your monthly income for December 2017 was at least \$1,922.00, which is the amount you receive in Social Security Disability benefits.
- 7) Your application states that you will not be taking any deductions on your 2018 tax return.
- 8) Your application states that you live in Nassau County, NY.
- 9) You testified that you have bills including utilities and other living expense that you think should be deducted from your household income.
- 10)You testified that you are unable to afford your health insurance premium along with the co-pays that are associated with your qualified health plan. You would like to be found eligible for a more affordable program.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Advance Payments of Premium Tax Credit

APTC are generally available to a person who is eligible to enroll in a qualified health plan and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a qualified health plan, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 26 CFR § 1.36B-2, 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

 the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

minus

2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2018 is set by federal law at 2.01% to 9.56% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3, IRS Rev. Proc. 2017-36).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Federal Register 8831).

For annual household income in the range of at least 200% but less than 250% of the 2017 FPL, the expected contribution for 2018 is between 6.34% and 8.10% of the household income (26 CFR § 1.36B-3(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2017-36).

People who use the APTC to help pay health insurance premiums must file a federal tax return and reconcile their expected income (stated on NYSOH application) with their actual income (stated on their federal income tax return). Those who take less tax credit in advance than they claim on the tax return may get the rest of it as an income tax refund or have their tax bill reduced. Those who take more tax credit in advance than they can claim on their tax return will owe the difference as additional income taxes (26 CFR § 1.36B-4).

Cost-Sharing Reductions

Cost-sharing reductions are available to a person who (1) is eligible to enroll in a qualified health plan through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level qualified health plan (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable FPL or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Fed. Reg. 8831).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage; therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

<u>Medicaid</u>

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR

§ 435.4). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Modified Adjusted Gross Income

NYSOH bases its eligibility determinations on modified adjusted gross income as defined in the federal tax code (45 CFR § 155.300(a)). The term "modified adjusted gross income" means adjusted gross income increased by (1) any income that was excluded under 26 USC § 911 for United States citizens or residents living abroad, (2) tax-exempt interest received or accrued, and (3) Social Security benefits that were excluded from gross income under 26 USC § 86 (see 26 USC § 36B(d)(2)(B), 26 CFR § 1.36B-1(e)(2)).

"Adjusted gross income" means, in the case of an individual taxpayer, gross federal taxable income minus certain specific deductions, such as expenses reimbursed by an employer, losses from sale or exchange of property, losses from premature withdrawal of finds from time savings accounts, deductions attributable to royalties, and certain retirement savings (26 USC § 62(a)). Living expenses, such as rent and utilities are not an allowable deduction in computing adjusted gross income (*id*.).

Legal Analysis

The first issue under review is whether NYSOH properly determined that you were eligible for up to \$407.00 per month in APTC.

The application that was submitted on December 7, 2017, listed an annual household income of \$24,364.00 and the eligibility determination relied upon that information.

During the hearing, you testified that the amount you provided in your application was correct. However, you asked that your current expenses, which include utilities and other living expenses, be considered when calculating your annual household income.

Since the Internal Revenue Service rules do not allow living expenses such as car insurance, cable, and other living expenses to be deducted from the calculation of your adjusted gross income, they cannot be deducted when the NYSOH computes your modified adjusted gross income for APTC purposes.

Therefore, NYSOH correctly determined your annual household income to be \$24,364.00, based on the information you provided.

You are in a one-person household for purposes of this analysis. This is because you expect to file your 2018 income tax return as single and will claim no dependents on that tax return.

You reside in Nassau County, where the second lowest cost silver plan available for an individual through NYSOH in 2018 costs \$536.95 per month.

An annual income of \$24,364.00 is 202.02% of the 2017 FPL for a one-person household. At 202.02% of the FPL, the expected contribution to the cost of the health insurance premium in 2018 is 6.41% of income, or \$130.14 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for an individual in your county (\$536.95 per month) minus your expected contribution (\$130.14 per month), which equals \$406.81 per month. Therefore, rounding to the nearest dollar, NYSOH correctly determined you to be eligible for up to \$407.00 per month in APTC.

The second issue under review is whether you were properly determined eligible for cost-sharing reductions.

Cost-sharing reductions are available to a person who has a household income no greater than 250% of the FPL. Since a household income of \$24,364.00 is 202.02% of the applicable FPL, NYSOH correctly found you to be eligible for cost sharing reductions.

The third issue under review is whether NYSOH properly determined you were ineligible for the Essential Plan.

The Essential Plan is generally provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. There is no indication in the record that you would be ineligible for the Essential Plan based on non-financial requirements.

On the date of your application, the relevant FPL was \$12,060.00 for a oneperson household. Since an annual household income of \$24,364.00 is 202.02% of the 2017 FPL, NYSOH correctly found you to be ineligible for the Essential Plan. The fourth issue under review is whether NYSOH properly determined that you were ineligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. There is no indication in the record that you would be ineligible for Medicaid based on non-financial requirements.

On the date of your application, the relevant FPL was \$12,060.00 for a oneperson household. Since \$24,364.00 is 202.02% of the 2017 FPL, NYSOH properly found you to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size. To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,387.00 per month.

On December 6, 2017, you faxed your Notice of Award letter from the Social Security Administration to NYSOH, which stated that you receive \$1,922.00 per month in Social Security Disability. You testified that you also receive about \$1,300.00 annually in IRA distributions. You further testified that you receive these distributions every three months and you are not sure whether you received a distribution payment in the month of December 2017.

However, since the documentation you provided, and your testimony, indicate that you received at least \$1,922.00 in income during December 2017, which exceeds the maximum allowable monthly income limit of \$1,387.00, you do not qualify for Medicaid based on monthly income as of the date of your application.

Since the December 8, 2017 eligibility determination notice properly stated that, based on the information you provided, you were eligible for up to \$407.00 per month in APTC, eligible for cost-sharing reductions, ineligible for the Essential Plan, and ineligible for Medicaid, it is correct and is AFFIRMED.

Decision

The December 8, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

NYSOH properly determined that you were eligible for up to \$407.00 per month in APTC in 2018.

NYSOH properly determined that you were eligible for cost-sharing reductions.

NYSOH properly determined that you were ineligible for the Essential Plan.

NYSOH properly determined that you were ineligible for Medicaid.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
