## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your eligibility for and enrollment in the Essential Plan was effective March 1, 2018?

# **Procedural History**

On September 16, 2016, NY State of Health (NYSOH) issued a renewal notice that stated it was time to renew your health insurance for the upcoming coverage year. That notice stated that, based on information from federal and state sources, NYSOH could not make a decision about whether you would qualify for financial help paying for your health coverage, and that you needed to update your account between September 15, 2016 and October 15, 2016 or you might lose the financial assistance you were currently receiving.

No update was made to your NYSOH account by October 15, 2016.

On October 17, 2016, NYSOH issued a notice stating that you were no longer eligible to receive health insurance through NYSOH, effective November 1, 2016. This notice stating that this was because you failed to respond to the renewal notice within the required timeframe.

Also on October 17, 2016, NYSOH issued a plan disenrollment notice stating that your enrollment in your Medicaid Managed Care plan terminated, effective October 31, 2016.

On January 22, 2018, NYSOH received your updated application for financial assistance with health insurance. That day, a preliminary eligibility determination was prepared stating that you were eligible to enroll in an Essential Plan with a \$20.00 monthly premium, effective March 1, 2018.

Also on January 22, 2018, you spoke to the NYSOH's Accounts Review Unit and appealed the preliminary eligibility determination insofar as you were not found eligible to enroll in an Essential Plan as of January 1, 2018.

On January 23, 2018, NYSOH issued an eligibility determination notice stating that you were eligible to enroll in an Essential Plan with a \$20.00 monthly premium, effective March 1, 2018.

Also on January 23, 2018, NYSOH issued a plan enrollment notice confirming your selection of an Essential Plan, with an enrollment start date of March 1, 2018.

On March 23, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and the record was closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) According to your NYSOH account, you have not had health insurance through NYSOH since November 1, 2016.
- 2) You testfied that you were unaware that you did not have health insurance coverage until you were informed by your doctor's office, that your health insurance had lapsed.
- 3) You testified that you did not receive any notice from NYSOH informing you that your health insurance coverage had ended.
- 4) According to your NYSOH account and your testimony, you receive all your notices from NYSOH by regular mail.
- 5) No notices sent to you at your mailing address listed on your NYSOH account have been returned as undeliverable.
- 6) You submitted an application to NYSOH for financial assistance on January 22, 2018.

- 7) According to your NYSOH account and your testimony, you enrolled in an Essential Plan on January 22, 2018.
- 8) You testified that you wanted your enrollment in an Essential Plan to begin on January 1, 2018 ,because you have unpaid medical bills from that month.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

## Medicaid Renewal

In general, NYSOH must review Medicaid eligibility once every twelve months or "whenever it receives information about a change in a beneficiary's circumstances that may affect eligibility" (42 CFR § 435.916(a)(1), (d)). NYSOH must make its "redetermination of eligibility without requiring information from the individual if able to do so based on reliable information contained in the individual's account or other more current information available to the agency, including but not limited to information accessed through any data bases accessed by the agency" (42 CFR § 435.916(a)(2)).

NYSOH must provide an individual with the annual redetermination notice, including the projected eligibility for coverage and financial assistance, and must require the qualified individual to report any changes within 30 days (45 CFR § 155.335(c), (e)). Once the 30-day period has lapsed, NYSOH must issue a redetermination as provided by the notice, with consideration given to any updates provided by the individual (45 CFR §155.335(h)).

## Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last

day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

# Legal Analysis

The issue under review is whether NYSOH properly determined that your eligibility for and enrollment in the Essential Plan was effective March 1, 2018.

Your NYSOH account indicates that you have not had health insurance coverage through NYSOH since November 1, 2016. You testified that you did not receive notice from NYSOH that your health insurance coverage had ended and that you did not know that you no longer had health insurance coverage until January 2018, when you were informed by your doctor's office that your health insurance coverage had lapsed.

You testified, and your NYSOH account confirms, that you elected to receive notifications by regular mail. However, there is no evidence in the record that any of the notices that were sent to your mailing address were returned as undeliverable, including the September 16, 2016 renewal notice, and the October 17, 2016 plan disenrollment and discontinuance notices.

Therefore, the record reflects that NYSOH properly notified you of your annual renewal, and that information in your NYSOH account needed to be updated to ensure your enrollment in your health plan and eligibility for financial assistance would continue and your health insurance coverage had ended due to failure to respond to the annual renewal.

The record shows that, on January 22, 2018, you updated the information in your NYSOH account and selected an Essential Plan.

The date on which the Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected after the fifteenth day of a month goes into effect on the first day of the second following month.

Since you selected your Essential Plan on January 22, 2018, it must take effect on the first day of the second following month after January 2018; that is, on March 1, 2018.

Therefore, NYSOH's January 23, 2018 eligibility determination notice and enrollment confirmation notice are AFFIRMED because they properly began your eligibility for and enrollment in the Essential Plan on March 1, 2018.

# Decision

The January 23, 2018 eligibility determination notice is AFFIRMED.

The January 23, 2018 plan enrollment notice is AFFIRMED.

## How this Decision Affects Your Eligibility

This decision does not change your eligibility.

The effective date of your Essential Plan is March 1, 2018.

# If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
