Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were not eligible for the Essential Plan, to receive tax credits or cost-sharing reductions to help pay for the cost of insurance, or to enroll in a qualified health plan at full cost through NYSOH, because you were not considered lawfully present?

Did NYSOH properly determine that you were ineligible for Medicaid?

Procedural History

On January 3, 2018, NYSOH received your updated application for health insurance. That day, NYSOH prepared a preliminary eligibility determination with regard to that application, stating that you were eligible for the Essential Plan for a limited time, effective February 1, 2018, however, you must return required documents to NYSOH to continue your coverage.

Also on January 3, 2018, NYSOH received a copy of your I-776 Employment Authorization Card reflecting a category code of "C33." This document was reviewed and verified on January 3, 2018 as valid proof of your immigration status.

On January 4, 2018, NYSOH issued an eligibility redetermination notice based on information verified on January 3, 2018. The notice stated that you were not eligible for Medicaid. This was because your income was over the allowable

income limit for that program. The notice also stated that you were not eligible for the Essential Plan, to receive tax credits or cost-sharing reductions to help pay for the cost of insurance, or to enroll in a qualified health plan at full cost. This was because your “[v]erification documents show not lawfully present.”

On January 23, 2018, you contacted NYSOH’s Account Review Unit and requested an appeal of that eligibility determination insofar as you were not eligible for coverage through NYSOH.

On March 27, 2018, you had a telephone hearing with a Hearing Officer from NYSOH’s Appeals Unit. During the hearing, Spanish Interpreter [REDACTED] translated. The record was developed during the hearing and held open until April 17, 2018, to allow you to submit supporting documents.

On April 10, 2018, the Appeals Unit received via fax a letter from your employer regarding your wages and your 2017 W-2. These documents were collectively marked as Appellant’s Exhibit #1 and incorporated into the record. The record is now closed.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) The record reflects that you expect to file your 2018 taxes with a status of head of household and you will claim two dependents on that tax return.
- 2) You are seeking insurance for yourself.
- 3) Your application states you are an immigrant non-citizen.
- 4) You uploaded a copy of your Employment Authorization card on January 3, 2018 with the status of C-33, which was verified on January 3, 2018.
- 5) The status of C-33, according to the United States Customs and Immigration Services (USCIS) and Social Security Administration (SSA) is in reference to a status classified as Deferred Action on Childhood Arrivals.
- 6) You testified that you do not currently have any pending applications to change your immigration status.
- 7) The application that was submitted on January 3, 2018, which requested financial assistance, listed annual household income of \$38,480.00, consisting of income you earn from employment. You testified that this amount was correct at the time. However, you have since received your

2017 W-2, and now believe that your 2018 income will be less than \$38,480.00.

- 8) You testified that your dependents do not have any income.
- 9) You testified that you worked for the same employer throughout 2017, and you received gross earnings of \$36,516.32. You anticipate that your earnings in 2018 will be similar to your earnings in 2017.
- 10) You submitted a copy of your 2017 W-2 which shows gross earnings of \$36,516.32.
- 11) You testified that your pay varies from week to week. You explained that in January 2018 you were working fewer hours and only one to two days per week. You explained that your employer did not have any steady jobs for you to work in January 2018. You estimated your January 2018 gross earnings at between \$1,000.00 and \$1,200.00.
- 12) You submitted a statement from your employer dated April 4, 2018 which states that you received gross pay of \$405.51 on January 5, 2018 and \$405.51 on January 25, 2018.
- 13) You testified that you are seeking to be found eligible to enroll in health insurance through NYSOH.
- 14) Your application states, and you confirmed, that you live in Suffolk County.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR

§ 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

Qualified Immigrants Transitioned to the Essential Plan

In New York State, qualified immigrants who were formerly eligible for Medicaid through the state, but not eligible for Medicaid under federal law, were transitioned to the Essential Plan as of January 1, 2016 (New York's Basic Health Plan Blueprint, p. 19, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>). This category of qualified immigrants includes individuals lawfully admitted for permanent residence in the United States who are still in their first five years of permanent residency (18 NYCRR § 349.3, 8 USC § 1613).

Medicaid

A person who meets certain nonfinancial criteria and has a household income that is at or below the applicable Medicaid income standard is eligible for Medicaid benefits (45 CFR § 155.305(c)). One of the non-financial criteria for Medicaid eligibility is the immigration status of the person applying for health insurance. A person is eligible for Medicaid when his or her immigration status is satisfactory and he or she meets all other requirements for Medicaid.

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$20,420.00 for a three-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Qualified Health Plan

To enroll in a qualified health plan (QHP) through the Marketplace, an applicant must be a citizen or national of the United States or a non-citizen who is lawfully

present in the United States and reasonably expects to become a citizen or remain a lawfully present noncitizen for the entire period for which enrollment is being sought (45 CFR § 155.305(a)(1)).

Advance Payments of Premium Tax Credit

Advance payments of the premium tax credit (APTC) are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

Cost-Sharing Reductions

Cost-sharing reductions (CSR) are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

Immigration Status

Generally, no person except a United States citizen, a naturalized citizen, a qualified alien, and persons permanently residing in the United States under color of law (PRUCOL), is eligible for medical assistance from the state (NY Soc. Serv. Law § 122(1); 18 NYCRR § 360-3.2(j)).

A PRUCOL alien is a person who is residing in the United States with the knowledge and permission or acquiescence of the federal immigration agency and whose departure from the United States such agency does not contemplate enforcing (18 NYCRR §360-3.2(j)). The New York Department of Health regards aliens who have been issued an Employment Authorization Document (I-688B or I-766), and have the requisite category code, to be PRUCOL (08 OHIP/INF-4, dated August 4, 2008)).

The guide, “Key to I-766/I-688B, Employment Authorization Documents (EADs)”, defines certain codes on the USCIS Employment Authorization Documents” (08 MA/033, dated December 1, 2008, and as amended). It confirms that a person who has category code of “(c)(33)” has PRUCOL status for Medicaid and Child Health Plus only (*id.*).

Legal Analysis

The first issue under review is whether NYSOH properly determined that you were not eligible to enroll in the Essential Plan, to receive tax credits or cost-sharing reductions, or to enroll in a full cost qualified health plan through NYSOH, because you are not considered lawfully present.

On January 3, 2018, you submitted an updated application to NYSOH, which included your I-766 EAC number and reflected that you are an immigrant non-citizen. This information was verified and confirmed that you have a C-33 status. That application listed an annual household income of \$38,480.00 and the eligibility determination relied upon that information.

As a result, NYSOH issued an eligibility determination notice stating that you were not qualified to enroll in coverage through NYSOH because the documentation you provided showed that you were not lawfully present.

Your employment authorization documentation states you are an immigrant non-citizen with a C-33 status. The status of C-33, according to the United States Customs and Immigration Services (USCIS) and Social Security Administration (SSA) is in reference to a status classified as Deferred Action on Childhood Arrivals. Individuals who have obtained an Employment Authorization card with the status of C-33 category are persons considered not "lawfully present" for purposes of the federal definition, and are therefore not recognized as eligible to receive federal funding under those programs.

In addition, while individuals who have been determined to be qualified aliens and were formerly eligible for Medicaid through the state, but not eligible for Medicaid under federal law, were transitioned to the Essential Plan as of January 1, 2016, this is not the case for persons who received Deferred Action status.

Therefore, NYSOH was correct in finding you not eligible for coverage under the Essential Plan.

Additionally, federal regulations require that a person seeking enrollment in a qualified health plan through NYSOH have United States citizenship or satisfactory or immigration status. Under the federal regulations, individuals with Deferred Action for Childhood arrivals status are not considered to be lawfully present for the purposes of obtaining coverage in a qualified health plan through NYSOH. Therefore, NYSOH properly found you ineligible to enroll in a qualified health plan.

In order to be found eligible for advance payments of the premium tax credit or cost-sharing reductions, and individual must be eligible to enroll in a qualified health plan. As you are ineligible to enroll in a qualified health plan for 2018 for

the reasons noted above, NYSOH properly found you ineligible for advance payments of the premium tax credit and cost-sharing reductions.

Accordingly, the January 4, 2018 discontinuance notice properly found you to be ineligible to enroll in a qualified health plan, ineligible for APTC and cost-sharing reductions, and ineligible for the Essential Plan based on you not being considered lawfully present.

The second issue is whether NYSOH properly found you ineligible for Medicaid.

NY State has consistently recognized persons with Deferred Action status within the accepted meaning of "*PRUCOL alien*"; even though the federal government has not. The New York Court of Appeals ruled, in *Aliessa, et al. v. Novello* (96 NY 2d 418 [2001]), that New York must provide state-funded Medicaid to the lawfully residing immigrants who had been excluded from access to the federal Medicaid program.

Since your current Deferred Action status does confer PRUCOL status for individuals seeking Medicaid eligibility, we may review whether you met the financial criteria for Medicaid.

You expect to file your 2018 income taxes as head of household and will claim two dependents on that tax return. Therefore, you are in a three-person household.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size. On the date of your applications, the relevant FPL was \$20,420.00 for a three-person household. Since \$38,480.00 is 188.44% of the 2018 FPL, NYSOH properly found you to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

As NYSOH properly found you ineligible to enroll in the Essential Plan, to receive tax credits or cost-sharing reductions to help pay for the cost of insurance, or to enroll in a qualified health plan at full cost because you are not considered lawfully present, and ineligible for Medicaid as your income is over the allowable income limit for that program, the January 4, 2018 eligibility determination notice is AFFIRMED.

However, financial eligibility for Medicaid can also be based on current monthly household income and family size.

You submitted documentation that your gross income from your employment in January 2018 was \$811.02.

Since the record now contains a more accurate representation of what your income was for the month of January 2018, your case is RETURNED to NYSOH to redetermine your eligibility for Medicaid on a monthly income basis for the 2018 coverage year, based on a three-person household size and household income of \$811.02 for the month of January 2018.

Decision

The January 4, 2018 discontinuance notice is AFFIRMED.

Your case is RETURNED to NYSOH to redetermine your eligibility for Medicaid on a monthly income basis for the 2018 coverage year, based on a three-person household size and household income of \$811.02 for the month of January 2018.

How this Decision Affects Your Eligibility

You are not eligible for the Essential Plan, to receive tax credits or cost-sharing reductions to help pay for the cost of insurance, or to enroll in a qualified health plan at full cost because you are not lawfully present.

This is not a final determination of your eligibility for Medicaid. Your case is being sent back to NYSOH to redetermine your eligibility based on the information you submitted during your hearing.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the
