NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On January 3, 2018, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible for Medicaid for October 1, 2017 through December 31, 2017. You appealed this determination insofar as you had not been found eligible for Medicaid coverage during the months of August and September 2017.

On February 27, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for March 19, 2018, at 2:00 p.m.

On March 19, 2018 at 2:06 p.m., a Hearing Officer placed a call to the telephone number that you provided to NYSOH, which was [REDACTED]. Although you answered the call, you unilaterally terminated the call upon the Hearing Officer identifying himself. Accordingly, you did not appear for your hearing as scheduled.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
