## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you and your spouse's enrollment in a qualified health plan (QHP) and the application of advance payments of the premium tax credit (APTC) were effective no earlier than March 1, 2018?

## Procedural History

On January 10, 2018, you submitted an application for financial assistance with NYSOH.

On January 11, 2018, NYSOH issued a notice of eligibility determination stating that you and your spouse were conditionally eligible to receive up to \$567.00 per month in APTC and, if you selected a silver-level QHP, for cost-sharing reductions (CSR). This eligibility was effective February 1, 2018. The notice directed you to provide proof of income by April 9, 2018.

On January 24, 2018, you updated your NYSOH account and selected a health plan for you and your spouse. On that date a preliminary eligibility determination was prepared regarding that application stating that you and your spouse were enrolled in a QHP with APTC, effective March 1, 2018.

Also on January 24, 2018, you spoke to NYSOH's Account Review Unit and appealed the enrollment confirmation notice insofar it began you and your

spouse's financial assistance eligibility and enrollment in a QHP on March 1, 2018, and not January 1, 2018.

On January 25, 2018, NYSOH issued a letter confirming you and your spouse's enrollment in a QHP with a monthly premium responsibility of \$872.32, after your APTC of \$567.00 was applied, both effective March 1, 2018.

On April 3, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on January 10, 2018.
- 2) You and your spouse were determined conditionally eligible for \$567.00 per month in APTC, effective February 1, 2018.
- 3) You testified, and the record reflects, that you selected a QHP on January 24, 2018.
- 4) You and your spouse's enrollment in the plan became effective March 1, 2018.
- 5) You testified that you need you and your spouse's QHP and eligibility for financial assistance to begin on January 2018 because you have medical bills from January 2018 and February 2018.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### **Enrollment in a QHP**

The effective date of coverage by a QHP is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections

received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

## **Legal Analysis**

The issue under review is whether NYSOH properly determined that you and your spouse's enrollment in a QHP, as well as the application of APTC, was effective no earlier than March 1, 2018.

You submitted an application to NYSOH for financial assistance on January 10, 2018. You and your spouse were determined conditionally eligible for \$567.00 per month in APTC, effective February 1, 2018.

The record shows that January 24, 2018 you updated the information in your NYSOH account and submitted a request to enroll in a QHP. On January 25, 2018, NYSOH issued an enrollment confirmation notice stating that you and your spouse's enrollment in your QHP was effective March 1, 2018 and that APTC would be applied to your monthly premium effective March 1, 2018.

The date on which a QHP can take effect depends on the day a person selects the plan for enrollment. A plan that is selected from the first day to and including fifteenth day of a month goes into effect on the first day of the following month. For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month.

Since you selected a plan on January 24, 2018, you and your spouse's QHP was effective the first day of the second following month; that is, on March 1, 2018. Because you cannot receive APTC until such time as you owe premiums, your receipt of APTC also properly began on March 1, 2018.

Therefore, NYSOH's January 25, 2018 enrollment confirmation notice is **AFFIRMED** because it properly began you and your spouse's enrollment in your QHP as well as your APTC on March 1, 2018.

## **Decision**

The January 25, 2018 enrollment confirmation notice is **AFFIRMED**.

## **How this Decision Affects Your Eligibility**

This decision does not change you or your spouse's eligibility.

You and your spouse's enrollment in your QHP, and your eligibility for APTC properly began as of March 1, 2018.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
