Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your enrollment in an Essential Plan was effective March 1, 2018?

Procedural History

On January 18, 2018, NY State of Health (NYSOH) issued an eligibility determination notice, based on your January 17, 2018 application, stating that you were eligible to enroll in the Essential Plan, effective March 1, 2018.

Also on January 18, 2018, NYSOH issued a plan enrollment notice, based on your plan selection on January 17, 2018, stating that you were enrolled in an Essential Plan with a start date of March 1, 2018.

On January 25, 2018, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in the Essential insofar as it did not begin January 1, 2018.

On March 21, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted an initial application to NYSOH for financial assistance on January 17, 2018.
- 2) According to your NYSOH account and your testimony, you enrolled in an Essential Plan on January 17, 2018.
- 3) You testified that you were previously enrolled in Medicaid through the county, and you were first aware that your Medicaid coverage had ended in late December 2017 or early January 2018, when you went to the pharmacy.
- 4) According to your NYSOH account, you had Medicaid through the NYC Human Resources Administration (HRA).
- 5) You testified that you did not receive a notice that your Medicaid coverage through HRA would end.
- 6) You testified that you wanted your enrollment in an Essential Plan to begin on January 1, 2018, because you have outstanding bills for medical treatments and prescriptions required during January 2018 and February 2018.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see *also* 42

CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in the Essential Plan was effective March 1, 2018.

You testified that you were enrolled in Medicaid through your HRA in New York County until December 31, 2017. You explained that you only first realized your coverage had ended when you went to the pharmacy in late December 2017 or early January 2018. You also testified that you were never given any notice, written or otherwise, by New York County HRA that your Medicaid coverage was to end December 31, 2017.

NYSOH's Appeals Unit has no jurisdiction over New York County HRA and can only review the issue of your eligibility and plan enrollment start date. Any issues regarding lack of notice that your Medicaid coverage through New York County HRA was ending properly belong before NYS Office of Temporary and Disability Assistance (OTDA). Through the present appeal, you are requesting that your Essential Plan coverage through NYSOH be backdated to January 1, 2018, as you have outstanding bills for medical treatments and prescriptions required during January 2018 and February 2018.

You testified, and the record indicates, that you submitted your NYSOH application on January 17, 2018. As a result, you were found eligible for the Essential Plan as of March 1, 2018 and enrolled into a plan that day.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On January 17, 2018, you selected an Essential Plan, which is after the fifteenth of the month, so your enrollment properly took effect on the first day of the second month following January 2018; that is, on March 1, 2018.

Therefore, the January 18, 2018 plan enrollment notice stating that your enrollment in the Essential Plan was effective March 1, 2018, is correct and must be AFFIRMED.

Decision

The January 18, 2017 plan enrollment notice is AFFIRMED.

Effective Date of this Decision: April 10, 2018

How this Decision Affects Your Eligibility

This decision does not change your eligibility for or enrollment in the Essential Plan.

The effective start date of your Essential Health Plan is March 1, 2018.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
