Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that your daughter, [REDACTED], was eligible to enroll in the Essential Plan, effective March 1, 2018?

Did NYSOH properly determine that your daughter was not eligible for Medicaid, as of your January 23, 2018 application?

Procedural History

On January 23, 2018, NY State of Health (NYSOH) received your updated application for financial assistance.

On January 24, 2018, NYSOH issued an eligibility determination notice based on the January 23, 2018 application, stating that your daughter was eligible to enroll in the Essential Plan with a \$20.00 monthly premium, effective March 1, 2018. It further stated that your daughter was not eligible for Medicaid because her household income was over the allowable income limit for that program.

On January 25, 2018, you contacted NYSOH's Account Review Unit and requested an appeal of that eligibility determination insofar as your daughter was not found eligible for Medicaid.

On March 14, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and remained open as the Hearing Officer directed you to provide as additional

evidence to corroborate your testimony: all earnings statements issued to you by your employer during the month of January 2018. The record was to be closed 15 days after the hearing date, or upon the receipt of the above referenced documents, whichever occurred earlier.

On March 15, 2018, you provided to NYSOH Appeals Unit through facsimile four earnings statements issued to you by your employer during the month of January 2018.

Accordingly, the record was closed on March 15, 2018.

Findings of Fact

A review of the record support the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of head of household. You will claim your two children as dependents on that tax return.
- 2) You are seeking insurance for you and your daughter.
- 3) Your daughter was [REDACTED] as of the January 23, 2018 application.
- 4) The application that was submitted on January 23, 2018, which requested financial assistance, listed annual household income of \$33,280.00, consisting solely of income you received from your employment with [REDACTED]. You testified that this amount was correct.
- 5) You testified, and provided documentation, that your monthly income for the month of January 2018 was \$2,560.00
- 6) Your NYSOH application reflects that you will not be taking any deductions on your 2017 tax return.
- 7) You live in [REDACTED], New York.
- 8) You testified that you were seeking for your daughter to become eligible for Medicaid so that you could reduce her health insurance premium costs.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2017 FPL, which is \$20,420.00 for a three-person household (82 Federal Register 8831).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$20,420.00 for a three-person household (82 Fed Reg 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Legal Analysis

The first issue under review is whether properly determined that your daughter was eligible for the Essential Plan, effective March 1, 2018.

The application that was submitted on January 23, 2018 listed an annual household income of \$33,280.00, which consisted solely of income you received from your employment with [REDACTED]. The eligibility determination relied upon that information.

Your daughter was in a three-person household. You expect to file your 2017 income taxes as head of household, and would claim both of your children as dependents on that tax return.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income (MAGI) that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$20,420.00 for a three-person household. Since an annual household income of \$33,280.00 is 162.98% of the 2017 FPL, NYSOH properly found your daughter to be eligible for the Essential Plan.

The second issue is whether NYSOH properly determined that your daughter was not eligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$20,420.00 for a three-person household. Since \$33,280.00 is 162.98% of the 2017 FPL, NYSOH properly found your daughter to be no eligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

On March 15, 2018, you submitted four earnings statements to NYSOH Appeals Unit reflecting that you received \$2,560.00 during the month of January 2018.

To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$2,349.00 per month. Since the documentation you provided shows that you earned \$2,560.00 in January 2018 your daughter does not qualify for Medicaid based on monthly income as of the date of your application.

Since the January 24, 2018 eligibility determination notice properly stated that, based on the information you provided, your daughter was eligible for the Essential Plan, and not eligible for Medicaid, it was correct and is AFFIRMED.

Decision

The January 24, 2018 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

Your daughter was eligible for the Essential Plan, effective March 1, 2018.

Your daughter was not eligible for Medicaid.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
