## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly terminate your Essential Plan for non-payment of premium effective, January 1, 2018?

Did NYSOH properly determine that your reenrollment in the Essential Plan was effective March 1, 2018?

## Procedural History

On December 15, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to enroll in the Essential Plan, effective January 1, 2018.

Also on December 15, 2017, NYSOH issued a notice confirming your enrollment in an Essential Plan, effective January 1, 2018.

On January 26, 2018, NYSOH issued a disenrollment notice stating that your enrollment in your Essential Plan was terminated, effective January 1, 2018, because a premium payment had not been received by the health plan.

Also on January 26, 2018, you updated your application for financial assistance. That day, a preliminary eligibility determination was prepared stating that you were eligible to enroll in the Essential Plan and you selected a plan for enrollment.

Additionally, on January 26, 2018, you spoke to NYSOH's Account Review Unit and appealed the termination of your Essential Plan for the months of January 2018 and February 2018.

On January 27, 2018, NYSOH issued a notice of eligibility determination, based on your January 26, 2018 application, stating that you were eligible to enroll in the Essential Plan, effective March 1, 2018.

Also on January 27, 2018, NYSOH issue a notice of enrollment confirmation, based on your plan selection on January 26, 2018, stating that you were enrolled in an Essential Plan effective March 1, 2018.

On March 29, 2018, you were scheduled for a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. You requested that day that the hearing be adjourned to a later date.

On April 12, 2018, you had an adjourned telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. Under oath, you waived your right to formal notice of the hearing. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you are only appealing your disenrollment from your Essential Plan for the months of January 2018 and February 2018.
- 2) You were enrolled into an Essential Plan on December 14, 2017, effective January 1, 2018.
- 3) You testified that when you tried to pay your initial Essential Plan premium, you logged in to your Essential Plan carrier's website, at which time you were met with a message advising you to contact your Essential Plan carrier regarding payment. You explained that you had coverage through this insurance carrier in the past, and there had previously been a credit on your account. You stated that when you received the message advising you to contact your Essential Plan carrier, you thought you were receiving this message because you still had a credit on your account and that you did not need to do anything further. You did not make a payment at that time.
- 4) You were disenrolled from your Essential Plan, effective January 1, 2018.

- 5) You testified that you became aware that you had been disenrolled from your Essential Plan on January 26, 2018 when you received an e-mail alert from NYSOH advising you to log in to your account, at which time you saw the January 26, 2018 disenrollment notice.
- 6) You testified that when you became aware that you had been disenrolled you contacted NYSOH to reenroll.
- 7) On January 26, 2018, NYSOH received your updated application and Essential Plan selection.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Appealable Issues

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) an eligibility determination for an exemption; (4) a failure by NYSOH to provide timely notice of an eligibility determination 45 CFR § 155.505; and (5) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

### Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see *also* 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

## Legal Analysis

The first issue under review is whether NYSOH properly terminated your Essential Plan for non-payment of premium effective, January 1, 2018.

On December 14, 2017 you were enrolled in an Essential Plan, effective January 1, 2018.

You testified that you did not pay your Essential Plan premium for January 2018 due to some confusion regarding a credit you previously had with the same insurance carrier.

On January 26, 2018, NYSOH issued a notice stating that you were disenrolled from your Essential Plan for non-payment of premiums, effective January 1, 2018.

NYSOH Appeals Unit only has the authority to review issues related to the following: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (3) an eligibility determination for an exemption, (4) a failure to provide timely notice of an eligibility determination and (5) a denial of a special enrollment period.

Since the Appeals Unit is not given the authority to review termination of enrollment due to non-payment of premiums, we cannot reach the merits as to whether or not you were properly terminated from your Essential Plan for non-payment of premiums. Therefore, your appeal of the January 26, 2018 disenrollment notice is **DISMISSED** as a non-appealable issue.

The second issue is whether NYSOH properly determined that your reenrollment in your Essential Plan was effective March 1, 2018.

You contacted NYSOH on January 26, 2018 to reenroll into an Essential Plan.

The date on which an Essential Plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

As you contacted NYSOH to reenroll into an Essential Plan on January 26, 2018, your reenrollment should have taken effect the first day of the second month following after January 26, 2018; that is, on March 1, 2018.

Therefore, the January 27, 2018 enrollment confirmation notice stating that your reenrollment in your Essential Plan was effective March 1, 2018 is AFFIRMED.

## **Decision**

Your appeal of the insurer's termination of your enrollment in the Essential Plan for non-payment of premiums, effective January 1, 2018, is DISMISSED as a non-appealable issue.

The January 27, 2018 enrollment confirmation notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your eligibility.

Your reenrollment in an Essential Plan was effective March 1, 2018.

## **If You Disagree with this Decision (Appeal Rights)**

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the
