Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your and your spouse's application of advance payment of the premium tax credit up to \$562.00 per month was effective no earlier than February 1, 2018?

Procedural History

On December 9, 2017, NYSOH issued an eligibility determination notice stating you and your spouse were eligible to receive up to \$562.00 per month in advance payments of the premium tax credits (APTC). This eligibility was effective January 1, 2018.

On December 9, 2017, NYSOH issued a plan enrollment notice confirming your and your spouse's enrollment in a qualified health plan with a monthly premium responsibility of \$959.20, with no APTC applied to your premium, effective January 1, 2018.

On January 6, 2018, NYSOH issued a plan enrollment notice confirming your and your spouse's enrollment in a qualified health plan with a monthly premium responsibility of \$397.20, after your APTC of \$562.00 was applied. The notice stated the APTC will be applied to the monthly premium, effective February 1, 2018.

On January 26, 2018, you spoke to NYSOH's Account Review Unit and appealed start date of your and your spouse's APTC requesting it begin as of January 1, 2018, and not February 1, 2018.

On April 3, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on December 8, 2017.
- 2) According to your NYSOH account and your testimony, you selected a qualified health plan for yourself and your spouse on December 8, 2017.
- 3) Your and your spouse's enrollment in the plan became effective January 1, 2018.
- 4) The December 9, 2017 eligibility determination notice states you and your spouse are eligible for APTC up to \$562.00 per month, effective January 1, 2018.
- 5) The December 9, 2017 plan enrollment notice states \$0.00 in APTC was being applied to your plan as of January 1, 2018.
- 6) You testified that you need your eligibility for financial assistance to begin on January 1, 2018, because you cannot afford the full cost of your health plan's premium without the ATPC being applied, and your health plan is still billing you at full cost at the time of your hearing.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Redetermination During a Benefit Year

When a redetermination is issued as a result of a change in an applicant's information, NYSOH must generally make that redetermination effective on the first day of the month following the date NYSOH is notified of the change (45 CFR § 155.330 (f)(1)(ii)). However, NYSOH may determine that its policy will be

that any change made after the 15th of any month will not be effective until the first of the second following month (45 CFR § 155.330(f)(2)).

When an eligibility redetermination results in a change in the amount of APTC for the benefit year, NYSOH must recalculate the amount of APTC in such a manner as to account for any advance payments already made on behalf of the tax filer, such that the recalculated advance payment amount is projected to result in total advance payments for the benefit year that correspond to the tax filer's total projected premium tax credit for that benefit year (45 CFR § 155.330(g)).

Enrollment in a Qualified Health Plan

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether your and your spouse's application of APTC up to \$562.00 per month was effective no earlier than February 1, 2018.

The record shows that December 8, 2017, you updated the information in your NYSOH account and submitted a request to enroll in a qualified health plan. You and your spouse were determined eligible to receive up to \$562.00 per month in APTC. On December 9, 2017, NYSOH issued a plan enrollment notice stating that your and your spouse's enrollment in your qualified health plan was effective January 1, 2018, but that \$0.00 per month in APTC would be applied to your monthly premium effective January 1, 2018.

When an individual changes information in their application on or before the 15th of any month, NYSOH must make the redetermination that results from the change effective the first day of the following month. Since you and your spouse were determined eligible for up to \$562.00 per month in APTC on December 8, 2017, the APTC amount should have been applied to your monthly premium the first day of the month following December 2017; that is, on January 1, 2018.

Therefore, NYSOH's December 9, 2017 eligibility determination notice was proper and is AFFIRMED, and the December 9, 2017 plan enrollment confirmation notice is MODIFIED to state the application of APTC of \$562.00

Your case is RETURNED to NYSOH to change the start date of your and your spouse's eligibility for APTC to be applied as of January 1, 2018.

Decision

The December 9, 2017 eligibility determination notice was proper and is AFFIRMED.

The December 9, 2017 plan enrollment notice is MODIFIED to state the application of APTC of \$562.00 will be applied to your and your spouse's premium responsibility as of January 1, 2018.

Your case is RETURNED to NYSOH to change the start date of your and your spouse's eligibility for APTC to be applied as of January 1, 2018, and to notify you accordingly.

How this Decision Affects Your Eligibility

This decision does not change the amount of APTC you and your spouse were determined eligible to receive.

Your and your spouse's eligibility for APTC is to begin as of January 1, 2018, and your case is being sent back to NYSOH to make it effective as of that date. NYSOH will notify you once this has been done.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.
