Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were eligible to receive up to \$372.00 per month in advance payments of the premium tax credit, effective February 1, 2018?

Did NYSOH properly determine that you were eligible for cost-sharing reductions?

Did NYSOH properly determine that you were not eligible for the Essential Plan?

Procedural History

On January 9, 2018, you applied for health insurance and financial assistance through NYSOH.

Also on January 9, 2018, NYSOH received five earnings statements issued to you by your employer, [REDACTED], between December 6, 2017 and January 3, 2018.

On January 10, 2018, NYSOH issued an eligibility determination notice stating that you were eligible to receive up to \$372.00 in advance payments of the premium tax credit (APTC) as well as cost-sharing reductions (CSR) if you enrolled in a silver level qualified health plan, effective February 1, 2018. That

notice also stated that you were not eligible for the Essential Plan because your annual household income was over the allowable income limits for that program.

On January 29, 2018, you spoke to NYSOH's Account Review Unit and appealed that eligibility determination notice insofar as you were not eligible for the Essential Plan. You were found eligible for "Aid to Continue" during the pendency of the appeal, so you were reenrolled in the Essential Plan for a limited time.

On March 28, 2018, your mother, [REDACTED] (acting as your Authorized Representative), had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record support the following findings of fact:

- 1) Your mother testified that you expect to file your tax return for 2018 with a tax filing status of single. You will claim no dependents on that tax return.
- 2) You are seeking insurance for yourself only.
- 3) The application that was submitted on January 9, 2018 listed annual household income of \$24,960.00, consisting of \$960.00 you earn from your employment with [REDACTED] once every two weeks. Your mother testified, and the income documentation you submitted on January 9, 2018, that this amount was amount was correct.
- 4) Your mother testified, and your income documentation you submitted on January 9, 2018 reflects, that you typically work 40 hours per week and are compensated at \$12.00 per hour.
- 5) Your application states that you will not be taking any deductions on your 2018 tax return.
- 6) You live in Kings County, New York.
- 7) Your mother testified that you could not afford a qualified health plan (QHP) and were seeking to remained enrolled in the Essential Plan since it would better cover your [REDACTED] needs which would result in more [REDACTED] for you.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Advance Payments of Premium Tax Credit

APTC are generally available to a person who is eligible to enroll in a qualified health plan and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a qualified health plan, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 26 CFR § 1.36B-2, 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

- 1) the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

minus

- 2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2018 is set by federal law at 2.01% to 9.56% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3, IRS Rev. Proc. 2017-36).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Federal Register 8831).

For annual household income in the range of at least 200% but less than 250% of the 2017 FPL, the expected contribution is between 6.34% and 8.10% of the household income (26 CFR § 1.36B-3(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2017-36).

Cost-Sharing Reductions

Cost-sharing reductions are available to a person who (1) is eligible to enroll in a qualified health plan through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year

for which coverage is requested, and (4) is enrolled in a silver-level qualified health plan (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable FPL or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Fed. Reg. 8831).

Legal Analysis

The first issue is whether NYSOH properly determined that you were eligible for up to \$372.00 per month in APTC.

The application that was submitted on January 9, 2018 listed an annual household income of \$24,960.00 and the eligibility determination relied upon that information.

You are in a one-person household. You expect to file your 2018 income tax return as single and will claim no dependents on that tax return.

You reside in Kings County, where the second lowest cost silver plan available for an individual through NYSOH costs \$509.30 per month.

An annual income of \$24,960.00 is 206.97% of the 2017 FPL for a one-person household. At 206.97% of the FPL, the expected contribution to the cost of the health insurance premium is 6.59% of income, or \$136.97 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for an individual in your county (\$509.30 per month) minus your expected contribution (\$136.97 per month), which equals \$372.33 per month. Therefore, rounding to the nearest dollar, NYSOH correctly determined you to be eligible for up to \$372.33 per month in APTC.

The second issue is whether you were properly determined eligible for CSR.

CSR are available to a person who has a household income no greater than 250% of the FPL. Since a household income of \$24,960.00 is 206.97% of the applicable FPL, NYSOH correctly found you to be eligible for CSR.

The third issue under review is whether NYSOH properly determined you were not eligible for the Essential Plan.

The Essential Plan is generally provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$12,060.00 for a one-person household. Since an annual household income of \$24,960.00 is 206.97% of the 2017 FPL, NYSOH correctly found you to be not eligible for the Essential Plan.

Since the January 10, 2018 eligibility determination notice properly stated that, based on the information you provided, you were eligible for up to \$372.00 per month in APTC, eligible for CSR, and not eligible for the Essential Plan, it is correct and is AFFIRMED.

Decision

The January 10, 2018 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You remain eligible for an APTC of up to \$372.00 per month and, if you selected a silver-level plan, eligible for CSR, effective February 1, 2018.

You are not eligible for the Essential Plan, and your limited enrollment in that coverage will end.

Your case is returned to NYSOH to assist you in enrolling a plan for which you are eligible.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
