#### Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in a Medicaid Managed Care plan was effective February 1, 2018?

# **Procedural History**

On December 9, 2017, NYSOH received your initial application for financial assistance with health insurance.

On December 10, 2017, NYSOH issued a notice stating that the income information contained in your application did not match information NYSOH obtained from stated and federal sources. You were requested to provide proof of your household income by December 24, 2017 so that NYSOH could issue an appropriate eligibility determination.

On December 15, 2017, NYSOH received an unemployment insurance monetary benefit determination issued by the 2017.

Also on December 15, 2017, NYSOH redetermined your eligibility for financial assistance with health insurance.

On December 16, 2017, NYSOH issued an eligibility determination notice stating that you were eligible for Medicaid, effective December 1, 2017. The notice advised you to select a health plan.

On December 21, 2017, NYSOH issued an enrollment notice confirming your selection of a Medicaid Managed Care (MMC) plan as of December 20, 2017. This notice stated that your MMC plan coverage would begin effective February 1, 2018.

On January 29, 2018, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in a MMC plan, insofar as it did not begin on January 1, 2018.

On March 19, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record support the following findings of fact:

- You initially applied to NYSOH for financial assistance with your health insurance on December 9, 2017. In response to this application, NYSOH requested that you provide additional income documentation by December 24, 2017 so that your eligibility could be determined.
- 2) On December 15, 2017, you provided an unemployment insurance monetary benefit determination issued by the December 4, 2017. NYSOH confirm this as acceptable documentation proving your household on December 15, 2017.
- NYSOH redetermined your eligibility for financial assistance with health insurance on December 15, 2017 based, in part, on the documentation you provided.
- 4) As reflected in the December 16, 2017 eligibility determination, you were found eligible for Medicaid, effective December 1, 2017.
- 5) You testified, and the record reflects, that you selected your MMC plan on December 20, 2017, and that your enrollment was effective on February 1, 2018.
- 6) You testified that you wanted coverage under your MMC plan to begin on January 1, 2018 because you incurred some medical expenses that month that were not covered by fee-for-service Medicaid.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

# **Applicable Law and Regulations**

#### Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

# Legal Analysis

The issue is whether NYSOH properly determined that your enrollment in the MMC plan was effective February 1, 2018.

As reflected in the December 16, 2017 eligibility determination notice, you were found eligible for Medicaid, effective December 1, 2017.

You testified that you contacted NYSOH on December 20, 2017 and enrolled into an MMC plan.

The date on which a MMC plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On December 20, 2017, you selected an MMC plan for your coverage, so it properly took effect on the first day of the second month following December 2017; that is, on February 1, 2018.

Therefore, the December 21, 2017 enrollment notice stating that your enrollment in your MMC plan would be effective February 1, 2018, was correct and must be AFFIRMED.

#### **Decision**

The December 21, 2017 enrollment notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your eligibility.

The effective date of your MMC plan is February 1, 2018.

## If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your appeal was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
