Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly terminate your child's Child Health Plus plan for non-payment of premium, effective December 31, 2017?

Did NYSOH properly determine that your child's re-enrollment in her Child Health Plus plan was effective February 1, 2018?

Procedural History

On April 21, 2017, NYSOH issued an eligibility determination notice, based on your April 20, 2017 application, stating that your child was eligible for Child Health Plus at \$15.00 per month, effective June 1, 2017.

On April 21, 2017, NYSOH issued a plan enrollment notice confirming your child were enrolled in a Child Health Plus plan for a cost of \$15.00 per month with a start date of June 1, 2017.

On January 10, 2018, NYSOH issued a notice stating your child's coverage would end on December 31, 2017. The notice stated this was because you did not pay your insurance bill by the payment deadline.

On January 16, 2018, NYSOH issued an eligibility determination notice, based on your January 15, 2018 application, stating your child was eligible for Child Health Plus for a cost of 415.00 per month, effective February 1, 2018.

On January 16, 2018, NYSOH issued a plan enrollment notice confirming your child's enrollment in a Child Health Plus plan for a cost of \$15.00 per month, effective February 1, 2018.

On January 29, 2018, you spoke to NYSOH's Account Review Unit and appealed the start date of your child's Child Health Plus plan requesting a start date of January 1, 2018.

On April 27, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are only appealing your child's disenrollment from her Child Health Plus plan and new enrollment start date of February 1, 2018, requesting a January 1, 2018 start date instead.
- 2) Your child was enrolled into a Child Health Plus plan for a cost of \$15.00 per month, effective June 1, 2017.
- 3) You testified that you were told by your child's health plan you missed your December 2017 premium payment. You explained you would make payments for two months at a time and you believed your last payment was in November 2017.
- 4) You testified that you did not realize your child had been disenrolled until the middle of January 2018. You testified you then called your child's health plan on January 10, 2018, and tried to make a payment to the number on the back of the insurance card.
- 5) Your child was disenrolled from her Child Health plus plan, effective December 31, 2017.
- 6) According to your NYSOH account, you updated your child's application and re-enrolled her into a Child Health Plus plan on January 15, 2018.
- 7) You testified that you incurred medical bills for your child of approximately [REDACTED], when she was without health insurance coverage for the month of January 2018.

- 8) Your application states that you and your child reside in [REDACTED], NY.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Appealable Issues

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) an eligibility determination for an exemption; (4) a failure by NYSOH to provide timely notice of an eligibility determination 45 CFR § 155.505; and (5) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

Child Health Plus

A child who meets the eligibility requirements for Child Health Plus may be eligible to receive a subsidy payment if the child resides in a household with a household income at or below 400% of the federal poverty level (FPL) (NY Public Health Law § 2511(2)(a)(iii)).

To be eligible for Child Health Plus, the child:

- Must be under 19 years of age;
- Must be a New York State Resident;
- Must not have other health insurance coverage; and
- Must not be eligible for, or enrolled in, Medicaid

(NY Public Health Law § 2511(2)(a)-(e)).

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the Child Health Plus premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child's period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The first issue under review is whether NYSOH properly terminated your child's Child Health Plus plan for non-payment of premium, effective December 31, 2017.

On April 20, 2017, your child was enrolled in a Child Health Plus plan at \$15.00 per month, effective June 1, 2017.

On January 10, 2018, NYSOH issued a disenrollment notice stating that your child's Child Health Plus plan enrollment was ending on December 31, 2017, because you did not pay your insurance bill by the payment deadline. You testified that you were told by your child's health plan you missed your December 2017 premium payment. You testified you typically made payments two months in advance and your last payment was in November 2017. You further testified that, when you realized your child was disenrolled, you then attempted to make a payment in January 2018 over the phone.

NYSOH Appeals Unit only has the authority to review issues related to the following: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (3) an eligibility determination for an exemption, (4) a failure to provide timely notice of an eligibility determination and (5) a denial of a special enrollment period.

Since the Appeals Unit is not given the authority to review termination of enrollment due to non-payment of premiums, we cannot reach the merits as to whether or not your child was properly terminated from her Child Health Plus plan for non-payment of premiums.

Therefore, your appeal of the January 10, 2018 disenrollment notice is DISMISSED as a non-appealable issue.

The second issue under review is whether NYSOH properly determined that your child's re-enrollment in her Child Health Plus plan was effective February 1, 2018.

You contacted NYSOH on January 15, 2018 to select and re-enroll your child into a Child Health Plus plan.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

As you contacted NYSOH to re-enroll your child into a Child Health Plus plan on January 15, 2018, her re-enrollment properly took effect the first day of the first month after January 2018; that is, on February 1, 2018.

Therefore, the January 16, 2018 plan enrollment notice stating that your child's re-enrollment in her Child Health Plus plan was effective February 1, 2018, is AFFIRMED.

Decision

Your appeal of the insurer's termination of your child's enrollment in her Child Health Plus plan for non-payment of premiums, effective December 31, 2017, is DISMISSED as a non-appealable issue.

The January 16, 2018 plan enrollment notice is AFFIRMED.

How this Decision Affects Your Eligibility

Your child did not have health insurance coverage through NYSOH for the month of January 2018.

Your child's re-enrollment in her Child Health Plus plan was effective February 1, 2018.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
