Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your silver level qualified health plan was effective March 1, 2018?

Procedural History

On December 15, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to purchase a qualified health plan at full cost through NYSOH, effective January 1, 2018.

Also on December 15, 2017, NYSOH issued a notice of enrollment confirmation stating that you were enrolled in a bronze level qualified health plan with a plan enrollment start date of January 1, 2018.

On January 29, 2018, you contacted NYSOH and selected a silver level qualified health plan.

Also on January 29, 2018, you spoke to NYSOH's Account Review Unit and appealed insofar as your enrollment in your silver level qualified health plan began on March 1, 2018, and not January 1, 2018.

On January 30, 2018, NYSOH issued a notice of enrollment confirmation stating that you were enrolled in a silver level qualified health plan with a plan enrollment start date of March 1, 2018.

Also on January 30, 2018, NYSOH issued a disenrollment notice stating that your coverage in your bronze level qualified health plan would end as of February 28, 2018.

On April 27, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for health insurance on December 14, 2017.
- 2) Your NYSOH account reflects that on December 14, 2017, you selected a bronze level qualified health plan for enrollment.
- 3) You testified that you initially selected the bronze level qualified health plan after discussions with both the health plan and [REDACTED] who works in [REDACTED].
- 4) You testified that in January 2018 you went to the pharmacy to fill prescriptions. It was at that time that you learned that the bronze level plan was not going to provide you with the coverage you needed due to medications that you must take as a result of [REDACTED].
- 5) You testified that you believe you contacted NYSOH on January 30, 2018 and requested to change your plan to a silver level qualified health plan.
- 6) Your NYSOH account reflects that you selected a silver level qualified health plan for enrollment on January 29, 2018.
- 7) Your enrollment in the silver level qualified health plan became effective March 1, 2018.
- 8) You testified that you need your silver level qualified health plan to begin on January 1, 2018 because you had significant out of pocket expenses for necessary medications.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Enrollment in a Qualified Health Plan

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in your silver level qualified health plan was effective March 1, 2018.

The record shows that on January 29, 2018 you submitted a request to enroll in a silver level qualified health plan. On January 30, 2018 NYSOH issued an enrollment confirmation notice stating that your enrollment in your silver level qualified health plan was effective March 1, 2018.

The date on which a qualified health plan can take effect depends on the day a person selects the plan for enrollment. A plan that is after the fifteenth day of a month goes into effect on the first day of the second following month.

As you selected a silver level qualified health plan for enrollment on January 29, 2018, your enrollment in a silver level qualified health plan properly began on the first day of the second month following after January 29, 2018; that is, on March 1, 2018.

Therefore, NYSOH's January 30, 2018 enrollment confirmation notice is **AFFIRMED** because it properly began your enrollment in your silver level qualified health plan on March 1, 2018.

Decision

The January 30, 2018 enrollment confirmation notice is **AFFIRMED**.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

Your enrollment in your silver level qualified health plan properly began as of March 1, 2018.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
