## NOTICE OF DISMISSAL

On January 30, 2018, NY State of Health (NYSOH) issued a notice of enrollment confirmation, stating that your oldest child was enrolled in a Child Health Plus plan, effective March 1, 2018. You appealed this notice.

On March 13, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for April 4, 2018 at 2:00 PM.

A Hearing Officer called you at 2:00 PM on April 4, 2018. Although you answered the call, you stated that you no longer needed your appeal, but that you were not able to remain on the call to be placed under oath and formally withdraw your appeal.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

### **How does this Dismissal Affect My Eligibility?**

The Appeals Unit of NYSOH will not review your appeal at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us, in writing, within 30 of the date on this notice. In that writing, you must explain why your hearing did not go forward as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
