Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your oldest child's enrollment in his Child Health Plus plan was effective February 1, 2018?

Procedural History

On December 22, 2017, NY State of Health (NYSOH) issued an eligibility determination notice, based on your oldest child's December 21, 2017 application, stating that your oldest child (child) was eligible to enroll in Child Health Plus (CHP) with a \$9.00 monthly premium, effective February 1, 2018.

Also on December 22, 2017, a plan enrollment notice was issued, based on your plan selection on December 21, 2017, confirming your child's enrollment in his CHP plan, effective February 1, 2018.

On January 30, 2018, you spoke to NYSOH's Account Review Unit and appealed the start date of your child's CHP plan insofar as it did not begin January 1, 2018.

On March 29, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing only your child's enrollment start date in his CHP plan.
- 2) According to your NYSOH account and testimony, you submitted an initial application to NYSOH for financial assistance on behalf of your child on December 21, 2017. You enrolled him into a CHP plan that same day.
- 3) You testified that you need your child's CHP plan to begin on January 1, 2018, because you have unpaid medical bills for that month.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

The "period of eligibility" for CHP is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

"A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage" (42 CFR § 457.340(f)).

The State of New York has provided that a child's period of eligibility for CHP begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue under review is whether NYSOH properly determined that your child's enrollment in his CHP plan was effective February 1, 2018.

According to your NYSOH account and testimony, you submitted an initial application to NYSOH for financial assistance on behalf of your child on December 21, 2017. You enrolled him into a CHP plan that same day.

The date on which a CHP plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since you selected your child's CHP plan on December 21, 2017, it must take effect on the first day of the second month following December 2017; that is, on February 1, 2018.

Therefore, NYSOH's December 22, 2017 plan enrollment notice is AFFIRMED because it properly began your child's enrollment in a CHP plan on February 1, 2018.

Decision

The December 22, 2017 plan enrollment notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your child's eligibility for CHP or enrollment start date in his CHP plan.

The effective date of your child's CHP plan is February 1, 2018.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
