NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On December 5, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that your request for Medicaid coverage from September 1, 2017 through October 31, 2017 had been denied. You appealed this determination.

On February 28, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for March 20, 2018 at 3:00 p.m.

On March 20, 2018, NYSOH received an appeal representative appointment form for your appeal. However, this document was not signed by you but instead it was signed by what appears to be [REDACTED] who was attempting to operate as your appeal representative.

On March 20, 2018, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 3:00 p.m., 3:15 p.m., and 3:30 p.m., but was unable to reach you. Since a valid appeal representative form needs to be signed by you, [REDACTED] was not contacted for the scheduled hearing.

Since you did not appear for your hearing as scheduled and no valid appeal representative form has been received, we are dismissing your appeal.

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
