Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly terminate your qualified health plan for non-payment of premium effective January 1, 2018?

Did NYSOH properly determine that your reenrollment in the qualified health plan was effective March 1, 2018?

Procedural History

On July 20, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to enroll in a qualified health plan, effective September 1, 2017.

On July 20, 2017, NYSOH issued a notice confirming your enrollment in a qualified health plan, effective September 1, 2017.

On October 28, 2017 NYSOH issued a notice that it was time to renew your health insurance for the upcoming coverage year. That notice stated that you were qualified to buy a qualified health plan at full cost, effective January 1, 2018. The notice further stated that no action was required on your part and you were re-enrolled into your silver-level qualified health plan.

On December 15, 2017, NYSOH issued a disenrollment notice stating that your enrollment in your qualified health plan was terminated, effective January 1, 2018, because a premium payment had not been received by the health plan.

On January 30, 2018, NYSOH received your application for health insurance.

On January 30, 2018, NYSOH prepared a preliminary eligibility determination stating that you were eligible for a qualified health plan at full cost, effective March 1, 2018. Also on that date, you re-enrolled in the same qualified health plan...

On January 30, 2018 you spoke to NYSOH's Account Review Unit and appealed your enrollment start date of your qualified health plan insofar as it was effective March 1, 2018 and not January 1, 2018.

On January 31, 2018, NYSOH issued a notice of eligibility redetermination, based on the January 30, 2018 application, stating that you were newly eligible to purchase a qualified health plan at full cost, effective March 1, 2018.

On January 31, 2018, NYSOH issued a notice confirming your enrollment in a qualified health plan, effective March 1, 2018.

On April 26, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you did not make either your November, 2017 or December, 2017 premium payments for your qualified health plan.
- You testified that you learned from qualified health plan in November, 2017 that you had been disenrolled from your qualified health plan for nonpayment of premiums.
- 3) You testified that in late December, 2017 you contacted your qualified health plan, and a representative provided you with incorrect information about the premium payment you would need to make to re-enroll in your qualified health plan effective January 1, 2018.
- 4) You testified that in January, 2018, you learned from your qualified health plan that you had made an insufficient premium payment and therefore you were not re-enrolled in your qualified health plan effective January 1, 2018.
- 5) You testified, and the record reflects, that you submitted an application to NYSOH for health insurance on January 30, 2018.

- 6) You testified, and the record reflects, that you selected a qualified health plan on January 30, 2018.
- 7) Your enrollment in the qualified health plan became effective March 1, 2018.
- 8) You testified that you need your qualified health plan to begin on January 1, 2018 because you incurred medical expenses in January, 2018.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Appealable Issues

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) an eligibility determination for an exemption; (4) a failure by NYSOH to provide timely notice of an eligibility determination 45 CFR § 155.505; and (5) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

Qualified Health Plan Effective Date

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The first issue under review is whether NYSOH properly terminated your qualified health plan for non-payment of premium, effective January 1, 2018.

On July 20, 2017, you were enrolled in a qualified health plan, effective September 1, 2017.

You testified that you did not make your premiums to your qualified health plan for November and December of 2017.

On December 15, 2017, NYSOH issued a notice stating that you were disenrolled from your qualified health plan for non-payment of premiums, effective January 1, 2018.

NYSOH Appeals Unit only has the authority to review issues related to the following: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (3) an eligibility determination for an exemption, (4) a failure to provide timely notice of an eligibility determination and (5) a denial of a special enrollment period.

Since the Appeals Unit is not given the authority to review termination of enrollment due to non-payment of premiums, we cannot reach the merits as to whether or not you were properly terminated from your qualified health plan for non-payment of premiums. Therefore, your appeal of the December 15, 2017 disenrollment notice is DISMISSED as a non-appealable issue.

The second issue is whether NYSOH properly determined that your reenrollment in your qualified health plan was effective March 1, 2018.

You contacted NYSOH on January 30, 2018 to reenroll into a qualified health plan.

The date on which a qualified health plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

As you contacted NYSOH to reenroll into a qualified health plan on January 30, 2018, your reenrollment should have taken effect the first day of the second following month after January 30, 2018; that is, on March 1, 2018.

Therefore, the January 31, 2018 enrollment confirmation notice stating that your reenrollment in your qualified health plan was effective March 1, 2018 is AFFIRMED.

Decision

Your appeal of the insurer's termination of your enrollment in the qualified health plan for non-payment of premiums, effective January 1, 2018, is DISMISSED as a non-appealable issue.

The January 31, 2018 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

Your reenrollment in a qualified health plan was effective March 1, 2018.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
