Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NYSOH properly determine that your children's eligibility for and enrollment in their Child Health Plus plan was effective March 1, 2018?

Procedural History

On December 16, 2016, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that your children were eligible for Child Health Plus effective January 1, 2017. Your children were subsequently enrolled in a Child Health Plus plan.

On October 24, 2017, NYSOH issued a notice that it was time to renew your children's health insurance. That notice stated that, based on information from federal and state sources, NYSOH could not determine whether your children would qualify for financial help paying for their health coverage, and that you needed to update your account by December 15, 2017 or your children might lose the financial assistance they were currently receiving.

No updates were made to your account by December 15, 2017.

On December 17, 2017, NYSOH issued an eligibility determination notice stating that your children were not eligible for Medicaid, Child Health Plus, or to receive tax credits or cost-sharing reductions to help pay for the cost of insurance. Your children also could not enroll in a qualified health plan at full cost. This was because you had not responded to the renewal notice and had not completed

your children's renewal within the required time frame. Your children's eligibility ended December 31, 2017.

Also on December 17, 2017, NYSOH issued a disenrollment notice stating that your children's Child Health Plus coverage was ending effective December 31, 2017.

On January 22, 2018, NYSOH received your children's updated application for health insurance.

On January 23, 2018, NYSOH issued a notice of eligibility determination, based on your January 22, 2018 application, stating that your children were eligible to enroll in Child Health Plus with a \$9.00 monthly premium each, effective March 1, 2018.

Also on January 23, 2018, NYSOH issued a notice of enrollment, based on your plan selection on January 22, 2018, stating that your children were enrolled in a Child Health Plus plan and that coverage would start on March 1, 2018.

On January 30, 2018, you spoke to NYSOH's Account Review Unit and appealed the start date of your children's Child Health Plus plan insofar as it did not begin January 1, 2018.

On March 28, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified, and the record reflects, that you receive your notices from NYSOH by regular mail.
- 2) You testified that you did not receive the October 24, 2017 renewal notice from NYSOH telling you that you needed to update your application to renew your children's coverage.
- 3) You testified that you did not know that you needed to update your account until [REDACTED] when you were advised by your children's doctor that they did not have health insurance coverage.
- 4) NYSOH records do not reflect that any of the notices that were sent to your mailing address were returned as undeliverable.

- 5) The record reflects that on January 22, 2018 NYSOH received your children's updated application for health insurance.
- 6) Your children were re-enrolled in Child Health Plus, effective March 1, 2018.
- 7) You testified that you are seeking that your children be enrolled in their Child Health Plus plan as of January 1, 2018.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Annual Eligibility Redetermination

Generally, when NYSOH conducts annual eligibility redeterminations for qualified individuals who are seeking financial assistance through insurance affordability programs for the upcoming year, NYSOH is required to request that the qualified individual provide updated income and family size information for use in an eligibility redetermination for the upcoming year (see 45 Code of Federal Regulations (CFR) § 155.335(a), (b)).

NYSOH must send an annual renewal notice that contains the individual's projected eligibility for the upcoming year (45 CFR § 155.335(c)(3)). If a qualified individual does not respond to the notice after a 30-day period, NYSOH must redetermine that individual's eligibility using the information and projected eligibility provided in the annual renewal notice (45 CFR § 155.335(g), (h)). NYSOH must ensure this redetermination is effective on the first day of the coverage year or in accordance with the rules specified in 45 CFR § 155.330(f) regarding effective dates, whichever is later (45 CFR § 155.335(i)).

Child Health Plus

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid, or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

"A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or

through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue under review is whether NYSOH properly determined that your children’s enrollment in their Child Health Plus plan was effective March 1, 2018.

Your children were originally found eligible for Child Health Plus effective January 1, 2017.

Generally, NYSOH must redetermine a qualified child's eligibility for Child Health Plus once every twelve months without requiring information from the individual if able to do so based on reliable information contained in the individual's account or other more current information available to the agency. NYSOH's October 24, 2017 renewal notice stated that there was not enough information to determine whether your children were eligible to continue their financial assistance for health insurance, and that you needed to supply additional information by December 15, 2017, or their financial assistance might end.

Because there was no timely response to this notice, your children’s coverage in their Child Health Plus plans ended effective December 31, 2017.

You testified that you did not receive any notice from NYSOH telling you that you needed to update the information in your NYSOH account on your children’s behalf. You testified, and your NYSOH account confirms, that you elected to receive notifications via regular mail. However, there is no evidence in the record that any of the notices that were sent to your mailing address were returned as undeliverable.

Therefore, the record reflects that NYSOH properly notified you of your children’s annual renewal and that information in your NYSOH account needed to be updated to ensure your child’s enrollment in their Child Health Plus plan and eligibility for financial assistance would continue.

You first renewed your children's eligibility for financial assistance through NYSOH on January 22, 2018, and enrolled your children into a Child Health Plus plan that day.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected between the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Therefore, NYSOH's January 23, 2018 eligibility determination notice and enrollment confirmation notices are AFFIRMED because they properly began your child's eligibility for and enrollment in Child Health Plus on March 1, 2018.

Decision

The January 23, 2018 eligibility determination notice is AFFIRMED.

The January 23, 2018 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your children's eligibility.

The effective date of your children's Child Health Plus plan is March 1, 2018.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the
