#### Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in a qualified health plan and the application of advance payments of the premium tax credit were effective no earlier than February 1, 2018?

# **Procedural History**

On January 13, 2018, NYSOH issued an eligibility determination notice, based on a January 12, 2018 application, stating that you were eligible to receive up to \$431.00 per month in advance payments of the premium tax credits (APTC) and, if you selected a silver-level qualified health plan, for cost-sharing reductions (CSR) for a limited time. This eligibility was effective February 1, 2018. The notice instructed you to submit proof of income by April 12, 2018.

On January 13, 2018, NYSOH issued a plan enrollment notice confirming your enrollment in a silver-level qualified health plan with a monthly premium responsibility of \$37.66, after your APTC of \$431.00 was applied, both effective February 1, 2018.

On January 31, 2018, you spoke to NYSOH's Account Review Unit and appealed the eligibility determination and plan enrollment notices insofar as they began your financial assistance and enrollment in a qualified health plan on February 1, 2018, and not January 1, 2018.

On March 30, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on January 12, 2018.
- 2) According to your NYSOH account and your testimony, you selected a qualified health plan for enrollment on January 12, 2018.
- 3) Your enrollment in the plan became effective February 1, 2018.
- 4) You testified that you need your qualified health plan and eligibility for financial assistance to begin on January 1, 2018, because you went to an emergency room in January 2018, and incurred medical bills.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

# **Applicable Law and Regulations**

#### Redetermination During a Benefit Year

When a redetermination is issued as a result of a change in an applicant's information, NYSOH must generally make that redetermination effective on the first day of the month following the date NYSOH is notified of the change (45 CFR § 155.330 (f)(1)(ii)). However, NYSOH may determine that its policy will be that any change made after the 15<sup>th</sup> of any month will not be effective until the first of the second following month (45 CFR § 155.330(f)(2)).

When an eligibility redetermination results in a change in the amount of advance payments of the premium tax credit (APTC) for the benefit year, NYSOH must recalculate the amount of APTC in such a manner as to account for any advance payments already made on behalf of the tax filer, such that the recalculated advance payment amount is projected to result in total advance payments for the benefit year that correspond to the tax filer's total projected premium tax credit for that benefit year (45 CFR § 155.330(g)).

#### Enrollment in a Qualified Health Plan

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

# **Legal Analysis**

The issue under review is whether NYSOH properly determine that your enrollment in a qualified health plan, as well as the application of APTC, was effective no earlier than February 1, 2018.

The record shows that January 12, 2018, you updated the information in your NYSOH account and selected a qualified health plan. On January 13, 2018 NYSOH issued eligibility and plan enrollment notices stating that you were eligible to receive APTC and your enrollment in your qualified health plan was effective February 1, 2018, with APTC of up to \$431.00 per month to be applied as of that date.

When an individual changes information in their application on or before the 15th of any month, NYSOH must make the redetermination that results from the change effective the first day of the following month. Additionally, the date on which a qualified health plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected from the first day to and including fifteenth day of a month goes into effect on the first day of the following month.

Since your application for financial assistance and plan selection for enrollment were submitted on January 12, 2018, the application of APTC and start of your qualified health plan would begin the first day of the first month following January 2018; that is, as of February 1, 2018.

Therefore, NYSOH's January 13, 2018 eligibility determination and plan enrollment notices are AFFIRMED, because your eligibility for APTC and enrollment in your qualified health plan properly began as of February 1, 2018.

#### **Decision**

The January 13, 2018 eligibility determination and plan enrollment notices were proper and are AFFIRMED.

# **How this Decision Affects Your Eligibility**

Your enrollment in your qualified health plan and your eligibility for APTC properly began as of February 1, 2018.

## If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
