Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in a qualified health plan was effective no earlier than March 1, 2018?

Procedural History

On January 30, 2018, you submitted a non-financial assistance application.

On January 31, 2018, NYSOH issued a notice of eligibility determination stating that you were newly eligible for a full cost qualified health plan. This eligibility was effective March 1, 2018.

Also on January 31, 2018, NYSOH issued a letter confirming your enrollment in a qualified health plan with a monthly premium responsibility of \$882.73, effective March 1, 2018.

Also on January 31, 2018, you spoke to NYSOH's Account Review Unit and appealed the eligibility determination and enrollment confirmation notices insofar as they began your enrollment in a qualified health plan on March 1, 2018, and not February 1, 2018.

On February 8, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. You waived timely notice of the scheduled hearing. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted a non-financial assistance application to NYSOH on January 30, 2018.
- 2) You were determined eligible to enroll in a full cost qualified health plan effective March 1, 2018.
- 3) You testified, and the record reflects, that you selected a qualified health plan on January 30, 2018.
- 4) Your enrollment in the plan became effective March 1, 2018.
- 5) You testified that you need your qualified health plan to begin on February 1, 2018 because you have [REDACTED] and are seeking to undergo [REDACTED] in February 2018.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Enrollment in a Qualified Health Plan

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in a qualified health plan was effective no earlier than March 1, 2018.

The record shows that you submitted a non-financial assistance application on January 30, 2018 and selected a qualified health plan that day. On January 31, 2018, NYSOH issued an eligibility determination and enrollment confirmation

notice stating that your enrollment in your qualified health plan was effective March 1, 2018.

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month. For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month.

Therefore, NYSOH's January 31, 2018 eligibility determination notice and enrollment confirmation notice are **AFFIRMED** because they properly began your enrollment in your qualified health plan on March 1, 2018.
