NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On January 31, 2018, NY State of Health (NYSOH) issued an enrollment notice stating that your Medicaid Managed Care plan would begin March 1, 2018. You appealed that determination insofar as your Medicaid Managed Care plan did not begin on February 1, 2018.

On February 22, 2018, NYSOH issued an eligibility determination notice stating that you were eligible to purchase a qualified health plan at full cost, effective April 1, 2018. That notice further stated that you were not eligible for Medicaid through NYSOH because you were already enrolled in Medicaid or another program.

Also on February 22, 2018, NYSOH issued a notice of disenrollment stating that you were disenrolled from your Medicaid Managed Care plan through NYSOH effective March 1, 2018.

On April 5, 2018, a Hearing Officer from the Appeals Unit of NYSOH called you and, with the assistance of Spanish interpreter [REDACTED], placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because your plan had already started. The Hearing Officer confirmed with you that you had coverage through your Local Department of Social Services and no longer had coverage through NYSOH.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
