Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your child's enrollment in his Child Health Plus plan was effective March 1, 2018?

Procedural History

On January 16, 2018, NY State of Health (NYSOH) issued an eligibility determination notice, based on your January 15, 2018 application, stating that your child was eligible to enroll in Child Health Plus with a \$45.00 monthly premium, for a limited time, effective February 1, 2018.

On February 2, 2018, you selected a Child Health Plus plan for your child's enrollment and this enrollment was effective March 1, 2018.

Also on February 2, 2018, you spoke to NYSOH's Account Review Unit and appealed the start date of your child's Child Health Plus plan insofar as it did not begin on February 1, 2018.

Also on February 3, 2018, NYSOH issued a plan enrollment notice, based on your plan selection on February 2, 2018, stating that your child enrolled in a Child Health Plus plan and his enrollment in the plan would start March 1, 2018.

On April 24, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record support the following findings of fact:

- 1) You testified that you are appealing your child's enrollment start date.
- 2) According to your NYSOH account, you submitted an updated application on January 15, 2018.
- 3) According to your NYSOH account and your testimony, your child was found eligible to enroll in a Child Health Plus plan with a \$45.00 monthly premium on January 15, 2018.
- 4) According to your NYSOH account, the update made on January 15, 2018 was made by username ' [REDACTED] ' which you testified is your NYSOH username.
- 5) You testified that you completed the application on January 15, 2018, without any assistance from NYSOH.
- 6) You testified that you were unaware that you had to select a Child Health Plus plan for your child's enrollment on January 15, 2018, after his new eligibility was determined by NYSOH.
- 7) According to your NYSOH account, you enrolled your child into a Child Health Plus plan on February 2, 2018.
- 8) You testified that you need your child's Child Health Plus plan to begin on February 1, 2018, because you have unpaid medical bills from the month of February 2018.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue under review is whether NYSOH properly determined that your child’s enrollment in his Child Health Plus plan was effective March 1, 2018.

You testified, and the record reflects, that, on January 15, 2018, an updated application submitted by you was received by NYSOH and your child was found eligible to enroll in a Child Health Plus plan with a \$45.00 monthly premium, effective February 1, 2018. However, the record indicates that a plan was not selected for your child’s enrollment on January 15, 2018. The record further indicates that the update made on January 15, 2018 was completed by the username ‘[REDACTED]’ which you testified is your NYSOH username. You testified that you completed the update to your NYSOH account on January 15, 2018 by yourself, but that you were unaware that you had to select a Child Health Plus plan for your child that day, after NYSOH redetermined his eligibility.

The record indicates that you selected a Child Health Plus plan for your child’s enrollment on February 2, 2018.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since you selected a plan for your child’s enrollment on February 2, 2018, NYSOH properly determined that your child’s Child Health Plus plan began on the first day of the month following February 2018, that is, on March 1, 2018.

Therefore, the February 3, 2018 plan enrollment notice stating that your child's enrollment in his Child Health Plus plan was effective March 1, 2018, is correct and must be AFFIRMED.

Decision

The February 3, 2018 plan enrollment notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your child's eligibility for Child Health Plus or enrollment in his Child Health Plus plan.

The effective enrollment start date of your child's Child Health Plus plan is March 1, 2018.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
