NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On February 2, 2018, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible for Medicaid, effective February 1, 2018 and that you could pick a plan. Also on February 2, 2018 NYSOH issued an enrollment notice stating your Medicaid Managed Care plan you selected would start on March 1, 2018. You appealed those determinations.

On April 24, 2018, a Hearing Officer from the Appeals Unit of NYSOH called you and placed you under oath. While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because of the elapsed time it took for your appeal to be heard.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

However, you specifically stated that serious changes needed to be made in the system. You stated that because the computer system would not let you select a Medicaid Managed Care plan while you were still on COBRA coverage, this resulted in you having Medicaid fee-for-service for the month of February 2018 before your Medicaid Managed Care plan began on March 1, 2018. As you had serious longstanding medical issues that required constant monitoring by your regular doctors, who did not take Medicaid fee-for-service, you had to go without seeing those doctors during the month of February 2018. You filed this appeal in

the hopes that the system could be changed to prevent a similar situation from happening with others.

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NYSOH will not be reviewing this matter at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
