NOTICE OF DISMISSAL

On January 19, 2018, NY State of Health (NYSOH) issued an eligibility determination notice stating that you were eligible for the Essential Plan for a limited time, effective March 1, 2018. You appealed this determination.

On April 2, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for April 30, 2018, at 1:00 p.m.

On April 30, 2018, a Hearing Officer from NYSOH's Appeals Unit called you at 1:00 p.m., 1:15 p.m., and 1:30 p.m. Although you answered the call at 1:30 p.m., you stated that you were at work and could not participate in the hearing.

The Hearing Officer agreed to adjourn your hearing to May 9, 2018, at 1:00 p.m., and advised you that you would be required to waive formal notice in order to proceed with the hearing that day. You agreed to the date and time of the adjourned hearing.

On May 9, 2018, the Hearing Officer placed a total of six calls to you, at 1:00 p.m., 1:15 p.m., 1:19 p.m., 1:25 p.m., 1:30 p.m., and 1:34 p.m. You answered the call at 1:15 p.m., and requested a return call after 4:00 p.m. The Hearing Officer declined to adjourn your hearing, and the call was dropped on your end. You also answered the call at 1:30 p.m., and agreed to proceed with the hearing. You were put under oath and waived your right to formal notice. However, the call

was again dropped on your end before the hearing was completed. The Hearing Officer called a final time at 1:34 p.m., but was unable to reach you.

Since your hearing did not go forward as scheduled or adjourned, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us, in writing, within 30 of the date on this notice. In that writing, you must explain why your hearing did not go forward as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you and you will receive a notice advising you of the date and time of the rescheduled hearing. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
