## NOTICE OF DISMISSAL – FAILURE TO APPEAR

On February 6, 2018, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible for advance payments of the premium tax credit up to \$292.00 per month, effective March 1, 2018. The notice stated you may be able to enroll in coverage if you qualify for a Special Enrollment Period, to find out if you qualify for a Special Enrollment Period sign into your account and answer the questions about the Special Enrollment Period for 2018. You appealed this determination.

On March 14, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for April 5, 2018, at 10:00 a.m.

On April 5, 2018, a Hearing Officer placed two calls to the telephone number that you provided to NYSOH, at 10:00 a.m. and 10:15 a.m., but was unable to reach you. At 10:30 a.m. you answered and identified yourself for the record. You explained that you had work and did not get a Notice of Hearing. You stated you moved to a new address than the one on the Notice of Hearing. Before the Hearing Officer could confirm a new date for your hearing you ended the call by stating you had to go.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
