## NOTICE OF DISMISSAL

On February 7, 2018, NY State of Health (NYSOH) issued a notice confirming that on February 6, 2018, you requested a telephone hearing.

On March 21, 2018, you uploaded a NYSOH "Appeal Request – Instructions" form to your NYSOH account. The form specifies that you were seeking to be found eligible for retroactive Medicaid coverage for the month of December 2017 (Document [REDACTED])

On March 23, 2018, NYSOH issued a Notice of Telephone Hearing, advising you that the hearing you requested was scheduled for April 17, 2018 at 2:00 pm.

On April 17, 2018, a Hearing Officer from the NYSOH Appeals Unit attempted to contact you using the telephone number you provided to NYSOH. An individual answered, identified themselves to be [REDACTED] and stated they were unable to talk because you were not currently in the United States.

NYSOH properly notified you of your scheduled telephone hearing, and you were not available to participate in the hearing. Therefore, we are dismissing your appeal.

### **How does this Dismissal Affect My Eligibility?**

The Appeals Unit of NY State of Health will not review your appeal at this time.

The NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
