Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you and your oldest child do not qualify to enroll in a qualified health plan outside of the open enrollment period, effective March 1, 2018?

Procedural History

On January 12, 2018, NYSOH received your application for health insurance.

On January 13, 2018, NYSOH issued a notice stating that the income information in your application did not match what NYSOH received from state and federal data sources. You were directed to provide proof of income for your household by January 27, 2018.

On January 25, 2018, you submitted income documentation.

Also on January 25, 2018, your documentation was verified as sufficient proof of income and an application was run on your and your oldest child's behalf.

On January 26, 2018, NYSOH issued an eligibility determination notice stating that you and your oldest child were eligible to receive advance premium tax credits (APTC) of up to \$514.00 per month, effective March 1, 2018. It further directed you to select a health plan.

On February 7, 2018, you and your oldest child attempted to enroll in a qualified health plan, but were unable.

Also on February 7, 2018, you spoke to NYSOH's Account Review Unit and appealed your inability to enroll into a qualified health plan outside of the open enrollment period.

On February 8, 2018, NYSOH issued a plan enrollment notice stating that you and your oldest child did not qualify to select a health plan outside of the open enrollment period for 2018.

On April 11, 2018, you had a scheduled telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. You were unable to participate in a hearing that day and the Hearing Officer agreed to adjourn your hearing to a later date.

On April 18, 2018, you had an adjourned telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) On January 12, 2018, you submitted an application for health insurance and were directed to produce proof of income.
- 2) You submitted income documentation on January 25, 2018, which was verified as sufficient proof of income by NYSOH that same day.
- 3) On January 25, 2018, NYSOH submitted an application on your behalf, and you and your oldest child were determined eligible for APTC.
- 4) On February 7, 2018, you attempted to enroll yourself and your oldest child in a qualified health plan, but were unable.
- 5) You testified that your previous coverage outside of NYSOH expired in November 2017 or December 2017. According to information in your NYSOH account, your and your oldest child's coverage ended on November 30, 2017.
- 6) You testified that you are appealing because you and your oldest child need health insurance for 2018.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Enrollment in a Qualified Health Plan

NYSOH must provide annual open enrollment periods during which time qualified individuals may enroll in a QHP and enrollees may change QHPs (45 CFR § 155.410(a)(1)).

For the benefit year beginning on January 1, 2018, the national annual open enrollment period began on November 1, 2017 and extended through December 15, 2017 (45 CFR § 155.410(e)(3)). NY State extended this enrollment period through January 31, 2018 for applications processed through NYSOH (https://www.health.ny.gov/press/releases/2017/2017-09-07_open_enrollment_dates.htm).

Special Enrollment Periods

After each open enrollment period ends, NYSOH provides special enrollment periods to qualified individuals. During a special enrollment period, a qualified individual may enroll in a qualified health plan, and an enrollee may change their enrollment to another plan. This is generally permitted when one of the following triggering events occur:

- (1) The qualified individual or his or her dependent either:
 - (i) Loses minimum essential coverage.
 - (ii) Is enrolled in any non-calendar year group health plan or individual health insurance coverage, even if the qualified individual or his or her dependent has the option to renew such coverage.
 - (iii) Loses pregnancy-related coverage.
 - (iv) Loses medically needy coverage as described under section 1902(a)(10)(C) of the Social Security Act only once per calendar year.
- (2)(i) The qualified individual gains a dependent or becomes a dependent through marriage, birth, adoption, placement for adoption, or placement in foster care, or through a child support order or other court order.
 - (ii) the enrollee loses a dependent or is no longer considered a dependent through divorce or legal separation as defined by State law in the State in which the divorce or legal separation occurs, or if the enrollee, or his or her dependent, dies.

(3) The qualified individual, or his or her dependent, becomes newly eligible for enrollment in a qualified health plan because he or she gains citizenship, status as a national, or lawful present or is no longer incarcerated.

(4) The qualified individual's or his or her dependent's, enrollment or non-enrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities.

(5) The enrollee or, his or her dependent adequately demonstrates to NYSOH that the qualified health plan in which he or she is enrolled substantially violated a material provision of its contract in relation to the enrollee;

(6) The enrollee or enrollee's dependent is newly eligible or ineligible for advance payments of the premium tax credit, or change in eligibility for cost-sharing reductions.

(7) The qualified individual or enrollee, or his or her dependent, gains access to new qualified health plan as a result of a permanent move and either—

(i) Had minimum essential coverage for one or more days during the 60 days preceding the date of the permanent move, or

(ii) Was living outside of the United States or in a United States territory at the time of the permanent move;

(8) The qualified individual or dependent who gains or maintains status as an Indian may enroll in a qualified health plan or change from one plan to another, once per month.

(9) The qualified individual or enrollee, or his or her dependent, demonstrates to the Exchange, in accordance with guidelines issued by HHS, that the individual meets other exceptional circumstances as the Exchange may provide;

(10) A qualified individual or enrollee—

(i) Is a victim of domestic abuse or spousal abandonment, including a dependent or unmarried victim within a household, is enrolled in minimum essential coverage and seeks to enroll in coverage separate from the perpetrator of the abuse or abandonment; or

(ii) Is a dependent of a victim of domestic abuse or spousal abandonment, on the same application as the victim, may enroll in coverage at the same time as the victim;

(11) A qualified individual or dependent—

(i) Applies for coverage through NYSOH during the annual open enrollment period or due to a qualifying event, is assessed as potentially eligible for Medicaid or Child Health Plus and is determined ineligible for Medicaid or Child Health Plus either after open enrollment has ended or more than 60 days after the qualifying event; or

(ii) Applies for coverage at their Local Department of Social Services or Human Resources Administration during the annual open enrollment period, and is determined ineligible for Medicaid or Child Health Plus after open enrollment has ended;

(12) The qualified individual or enrollee, or his or her dependent, adequately demonstrates to NYSOH that a material error related to plan benefits, service area, or premium influenced the qualified individual's or enrollee's decision to purchase a qualified health plan; or

(13) At the option of NYSOH, the qualified individual provides satisfactory documentary evidence to verify his or her eligibility for an insurance affordability program or enrollment following termination of enrollment due to a failure to verify such status within 90 days.

(45 CFR § 155.420(d)).

Generally, if a triggering life event occurs, the qualified individual or enrollee has 60 days from the date of a triggering event to select a qualified health plan (45 CFR § 155.420(c)(1)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you and your oldest child do not qualify to enroll in a qualified health plan outside of the open enrollment period, effective March 1, 2018.

NYSOH provided an open enrollment period from November 1, 2017 until January 31, 2018. Once the annual open enrollment period ends, a health plan enrollee must qualify for a special enrollment period in order to enroll in, or

change to another health plan offered in NYSOH. To qualify for a special enrollment period, a person must experience a triggering event.

You submitted an application for financial assistance with health insurance to NYSOH on January 12, 2018.

On January 13, 2018, NYSOH issued a notice stating that the income information in your January 12, 2018 application did not match what NYSOH received from state and federal data sources. You were directed to provide proof of income for your household by January 27, 2018.

On January 25, 2018, you submitted income documentation, and it was verified as sufficient proof of income. That day, an application was run on you and your oldest child's behalf. On January 26, 2018, NYSOH issued an eligibility determination notice stating that you and your oldest child were eligible to receive APTC of up to \$514.00 per month, effective March 1, 2018. It further directed you to select a health plan.

On February 7, 2018, you requested to enroll in a qualified health plan. On February 8, 2018, NYSOH issued a notice stating that you and your oldest child did not qualify to enroll in a qualified health plan outside of the open enrollment period.

You testified that you and your oldest child's previous insurance coverage ended in November 2017 or December 2017. The record reflects that you and your oldest child's coverage ended on November 30, 2017. Loss of insurance coverage outside of NYSOH is considered a triggering life event.

When a triggering life event occurs, the qualified individual has 60 days from the date of that event to select a qualified health plan.

Since 60 days from November 30, 2017 is January 29, 2018, you would have qualified to select a qualified health plan outside of the open enrollment period until January 29, 2018. Since this was also during the open enrollment period you and your oldest child would have qualified to select a health plan through January 31, 2018.

Your request to enroll into a qualified health plan did not occur until February 7, 2018; which is outside of the 60-day window and after the open enrollment period ended. Therefore, you and your oldest child did not qualify for a special enrollment period on either basis.

A special enrollment period may also be available to a qualified individual or dependent who applies for coverage during the annual open enrollment period or has a qualifying life event and is determined potentially eligible for Medicaid during that period and is later determined ineligible for Medicaid either after the

open enrollment period has ended or more than 60 days after the qualifying event.

The credible evidence of record reflects that you applied for health insurance coverage for you and your oldest child on January 12, 2018, during the 60-day period following a qualifying life event; that is, loss of your previous coverage. During that period, you and your oldest child were found potentially eligible for Medicaid and you were directed to submit proof of income, which you did timely on January 25, 2018, and which NYSOH verified as sufficient that same day. Thereafter, on January 26, 2018, you and your oldest child were determined eligible for APTC taking you and your oldest child out of pending Medicaid status. Since this determination occurred within 60 days of the qualifying life event, which ended as of January 29, 2018, and during the open enrollment period, which ended as of January 31, 2018, you and your oldest child were properly determined not eligible for a special enrollment period thereafter; specifically, on February 7, 2018.

Therefore, NYSOH's February 8, 2018 plan enrollment notice stating that you and your oldest child do not qualify to select a health plan outside of the open enrollment period for 2017 is AFFIRMED.

Decision

The February 8, 2018 plan enrollment notice is AFFIRMED.

How this Decision Affects Your Eligibility

You and your oldest child did not qualify for a special enrollment period as of February 7, 2018, nor do either of you at this time.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.
