## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your children's enrollment in their Child Health Plus (CHP) plan ended effective February 28, 2018?

## Procedural History

On October 30, 2017, NYSOH issued a renewal notice stating that your children were eligible for a full cost CHP plan with a \$218.53 monthly premium each, effective January 1, 2018.

On November 18, 2017, NYSOH issued an enrollment notice confirming your children's enrollment in a CHP plan effective January 1, 2018.

On February 8, 2018, you contacted NYSOH and requested that your children's CHP coverage end. On that date NYSOH prepared a preliminary eligibility determination stating that your children's CHP plan coverage was ending effective February 28, 2018.

Also on February 8, 2018, you contacted the NYSOH Account Review Unit and appealed the date your children were disenrolled from their CHP plans, requesting the disenrollment be made effective January 1, 2018.

On February 10, 2018, NYSOH issued a disenrollment notice indicating that coverage in your children's CHP plan would end effective February 28, 2018.

On April 16, 2018, you had a telephone hearing with a Hearing Officer from the NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the proceeding.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) Your children were enrolled in a CHP plan effective January 1, 2018.
- 2) You testified that your children became eligible for insurance through your spouse's employer as of January 1, 2018.
- 3) You testified that on February 8, 2018, you contacted NYSOH to disenroll your children from their CHP plan through NYSOH.
- 4) Your children's CHP coverage ended effective February 28, 2018.
- 5) You testified that your children did not use their CHP plan during January 2018 or February 2018.
- 6) You testified that you are seeking retroactive disenrollment from your children's CHP plan effective January 1, 2018.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Termination of a Qualified Health Plan

NYSOH must permit an enrollee to terminate his or her coverage with a qualified health plan coverage, with appropriate notice to the NYSOH or qualified health plan (45 CFR § 155.430(b)(1)(i)).

For enrollee-initiated terminations, the last day of coverage is either:

- 1) The termination date specified by the enrollee, if the enrollee provides reasonable notice (at least 14 days before the requested termination date);
- 2) Fourteen days after the enrollee requests the termination, if they do not provide reasonable notice; or

- 3) On a date on or after the date the enrollee requests the termination, if the enrollee's qualified health plan issuer and the enrollee agree to such a date

(45 CFR § 155.430(d)(2)(i)-(iii)).

NYSOH must permit an enrollee to retroactively terminate or cancel their enrollment in a qualified health plan if:

- 1) The enrollee demonstrates that they attempted to terminate their coverage and experienced a technical error that did not allow the coverage to be terminated, and requests retroactive termination within 60 days after they discovered the technical error.
- 2) The enrollment in the qualified health plan was unintentional, inadvertent, or erroneous and was the result of the error or misconduct of an officer, employee, or agent of NYSOH or HHS, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities. Such enrollee must request cancellation within 60 days of discovering the unintentional, inadvertent, or erroneous enrollment.
- 3) The enrollee was enrolled in a qualified health plan without their knowledge or consent by any third party, including third parties who have no connection with the Exchange, and requests cancellation within 60 days of discovering of the enrollment.

(45 CFR § 155.430(b)(2)(iv)(A-C)).

NYSOH permits a qualified health plan to terminate an individual's coverage if (1) the enrollee is no longer eligible for coverage or (2) non-payment of the premiums by the enrollee (45 CFR § 155.430(b)(2)(i)-(ii)).

## **Legal Analysis**

The issue under review is whether NYSOH properly determined that your children's enrollment in their CHP plan ended effective February 28, 2018.

On October 30, 2017, NYSOH issued a renewal notice stating that your children were eligible for a full cost CHP plan with a \$218.53 monthly premium each, effective January 1, 2018. You subsequently enrolled your children in a CHP plan.

On February 10, 2018, NYSOH issue a disenrollment notice indicating your children would be disenrolled from their CHP plan effective February 28, 2018.

You testified that you are seeking retroactive disenrollment from your children's CHP plan effective January 1, 2018.

NYSOH must permit an enrollee to be retroactively disenrolled from their qualified health plan if the enrollee demonstrates that there was a technical error that should have allowed them to terminate coverage earlier, or if their enrollment in the plan was unintentional, inadvertent, or erroneous and was the result of the error or misconduct of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities, or the enrollee was enrolled into a qualified health plan without their knowledge or consent by a third party.

There is no indication in the record that your children's enrollment in a CHP health plan as confirmed in the November 18, 2017 enrollment notice was unintentional, inadvertent, or erroneous, nor was your children's enrollment in a CHP plan the result of the error or misconduct of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities. Furthermore, there is no indication that your children's enrollment in a CHP plan as confirmed in the November 18, 2017 enrollment notice was without your knowledge or consent.

Therefore, there is no basis to find that NYSOH must permit your children to retroactively terminate or cancel their enrollment in a CHP plan.

The record reflects that on February 8, 2018, you contacted NYSOH and requested that your children be disenrolled from their CHP plan as you no longer wanted them to remain enrolled.

Enrollees must be allowed to terminate their coverage with a qualified health plan on the date they specify if they provide reasonable notice to NYSOH or to their health plan. Reasonable notice is defined as at least 14 days prior to the requested termination date.

NYSOH terminated your insurance coverage with your qualified health plan effective February 28, 2018, which is the last day of the month following your request.

Since your children do not qualify to be retroactively disenrolled from their coverage and you did not provide reasonable notice to NYSOH, NYSOH properly determined that your children's disenrollment in their CHP plan was effective February 28, 2018.

Therefore, the February 10, 2018, disenrollment notice is **AFFIRMED**.

## **Decision**

The February 10, 2018 disenrollment notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your children's disenrollment date. Your children's enrollment in their CHP plan ended as of February 28, 2018.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
