Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your Medicaid Managed Care (MMC) plan was effective March 1, 2018?

Procedural History

On February 15, 2018, you filed an application for financial assistance with health insurance through NYSOH. That same day, NYSOH prepared a preliminary eligibility determination stating you were eligible for Medicaid, effective February 1, 2018.

Also on February 15, 2018, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in your MMC plan, insofar as it did not begin February 1, 2018.

On February 16, 2018, NYSOH issued a notice of eligibility determination, based on your February 15, 2018 application, stating that you were eligible for Medicaid, effective February 1, 2018.

Also on February 16, 2018, NYSOH issued a notice of enrollment in the plan you selected on February 15, 2018, stating that you were enrolled in an MMC plan, and that your coverage would start on March 1, 2018.

On April 11, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record support the following findings of fact:

- 1) You testified you are appealing on behalf of yourself only.
- 2) You submitted an application to NYSOH for financial assistance on behalf of yourself and your two children on February 15, 2018, and you selected an MMC plan for enrollment on that day.
- 3) You were found eligible for Medicaid effective February 1, 2018, and your enrollment in your MMC plan began as of March 1, 2018.
- 4) You testified you previously had Medicaid coverage and were not informed that it was going to end on January 31, 2018.
- 5) You testified your previous Medicaid coverage was through the NYC Human Resources Administration (HRA).
- 6) You testified you usually received a letter from "Medicaid" telling you when you needed to recertify, but you did not receive one this year.
- 7) You testified you went to the "Medicaid office" when you found out your coverage had ended, and were told you needed to apply online for coverage through NYSOH, which you had never had to do before.
- 8) You testified you never received any notices from HRA telling you that your coverage was ending, and were not told that you could file an appeal about the termination of your coverage through HRA.
- 9) You testified you have medical bills for yourself from February 2018 for doctors who do not accept fee-for-service Medicaid, so you are looking for your MMC plan to be backdated.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

MMC plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in your MMC plan was effective March 1, 2018.

You testified, and your NYSOH account confirms, that you contacted NYSOH on February 15, 2018 and selected an MMC plan for enrollment on that day.

The date on which a MMC plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On February 15, 2018, you selected an MMC plan, so it properly took effect on the first day of the month following February; that is, on March 1, 2018.

Therefore, the February 16, 2018 enrollment confirmation notice stating that your enrollment in your MMC plan would be effective March 1, 2018, was correct and must be AFFIRMED.

If you believe that HRA did not provide you with timely and adequate written notice of the termination of your Medicaid coverage through HRA, you must file an appeal through HRA. The NYSOH Appeals Unit has no authority to review the actions of HRA.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

The effective date of your MMC plan is March 1, 2018.

If you wish to appeal HRA's termination of your Medicaid coverage at the end of January 2018, you must appeal directly through HRA, as the NYSOH Appeals Unit does not have the authority to review HRA's actions.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
