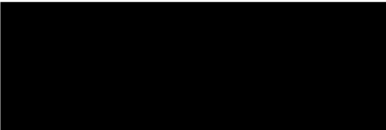

Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in a qualified health plan and the application of advance payments of the premium tax credit (APTC) were effective January 1, 2018?

Procedural History

On December 12, 2018, you updated your NYSOH account.

On December 13, 2017, NYSOH issued a notice of eligibility determination stating that you were conditionally eligible to receive up to \$266.00 per month in APTC. This eligibility was effective January 1, 2018.

Also on December 13, 2017, NYSOH issued a letter confirming your enrollment in a qualified health plan with a monthly premium responsibility of \$149.99, after your APTC of \$266.00 was applied, both effective January 1, 2018.

On February 20, 2018, you spoke to NYSOH's Account Review Unit and appealed the eligibility determination and enrollment confirmation notices insofar as they began your financial assistance eligibility and enrollment in a qualified health plan on January 1, 2018, and not February 1, 2018.

On April 24, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You applied to NYSOH for financial assistance on December 12, 2017.
- 2) You were determined conditionally eligible to receive up to \$266.00 per month in APTC. This eligibility was effective January 1, 2018.
- 3) You testified, and the record reflects, that you selected a qualified health plan on December 12, 2017.
- 4) Your enrollment in the plan became effective January 1, 2018.
- 5) You testified that you paid your January 2018 monthly premium.
- 6) You testified that you did not use your qualified health plan in January 2018.
- 7) You testified that you would like your qualified health plan and eligibility for financial assistance to begin on February 1, 2018.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Enrollment in a Qualified Health Plan

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether NYSOH properly determine that your enrollment in a qualified health plan, as well as the application of APTC, was effective January 1, 2018.

The record shows that December 12, 2017 you updated the information in your NYSOH account and submitted a request to enroll in a qualified health plan. On December 13, 2017 NYSOH issued an enrollment confirmation notice stating that your enrollment in your qualified health plan was effective January 1, 2018 and that APTC would be applied to your monthly premium effective January 1, 2018.

The date on which a qualified health plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected from the first day to and including fifteenth day of a month goes into effect on the first day of the following month. For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month.

You testified that you selected your qualified health plan on December 12, 2018. As such, your enrollment and application of APTC properly took effect on the first day of the next month; that is, on January 1, 2018.

Therefore, NYSOH's December 13, 2017 eligibility determination notice and December 13, 2017 enrollment confirmation notices are AFFIRMED because they properly began your enrollment in your qualified health plan as well as your advance premium tax credits on January 1, 2018.

Decision

The December 13, 2017 eligibility determination notice is AFFIRMED.

The December 13, 2017 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

Your enrollment in your qualified health plan, and your eligibility for APTC properly began as of January 1, 2018.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
